## Hopcroft and Croft Cottage, land to rear of - Lower Lake

Cllr Mrs Pry again highlighted concerns regarding various questionable activities at Farmeggs Farm, Kane Hythe Road, eg items for sale on an unsafe area, siting of a caravan, a large amount of iron and the movement of a large mound of earth; Cllr Mrs Fisher reported a large amount of granular material which is forming an access route into the field at Little Park Farm, Marley Lane and Cllr Mrs Kiloh raised the dilapidated state of Old House, Upper Lake. It was agreed that all these issues should be reported to Rother District Council.

An update on the resolution of the **poor state of the twitten between High Street and Mount Street** was requested and the Asst Clerk was asked to reiterate the Committee's concerns with regard to health and safety and duty of care issues.

Cllr Mrs Pry suggested that the language schools such as EF may be interested in using **Pyke House** for education purposes. This to be passed to **Sussex Coast**.
