B.Cllr Samuel reported that "One Council" didn't go ahead and a Financial Stability group has been formed as there are still concerns over the budget gap of £166k. She will be attending a meeting with a member of the Enforcement Team next week as concerns have been raised by several Parish Councils about applications not being enforced.

91.1 Neighbourhood Plan

Cllr Hedley reported the Group's consultant is currently working on the policy intents of the Neighbourhood Plan which hopefully, the Group will be able to develop and use as a basis for drafting the Neighbourhood Plan in due course.

91.2 TAP Fund

The Clerk confirmed the first instalment of £900 had been received and a request for the remaining £600 was sent on 10th November 2017.

91.3 Maintenance of Parish Assets

 Comments: The Parish Council supports the extension on the basis that the structure does not impact the original building and encompasses the philosophy of reversibility so it could be removed in the future without harm to the original building. Whilst the design is traditional, the detailing seems to be well informed.

- 93.4 3837/17/FUL: Land at SS603028, off Hayfield Lane, Exbourne for erection of a three-bay timber frame agricultural barn

 Comments: The Parish Council feels that the building may be larger than what is necessary for a holding of 6 acres, however, if the authority is satisfied there is a genuine agricultural need, the Parish Council does not object.

- 93.5 3759/17/FUL: Shilstone Farm, Exbourne EX20 3QS for change of use from existing bungalow as temporary agricultural dwelling house Comments: The Parish Council is aware that the previous application for an additional dwelling was refused because at that time there was not a genuine need for an additional agricultural dwelling. However, the Parish Council would not object if there is a proven agricultural need for two dwellings on this agricultural holding.
