The Council hereby REFUSES Planning Permission for the above for the following Reason(s):

(1) The proposal, involving the demolition of a modest single storey bungalow and outbuildings, by reason of the height, bulk, massing, and siting, of the large proposed two storey pitched roof replacement house and garage and introduction of excessive hard landscaping would erode the largely undeveloped rural nature of the site with a substantial increase in the bulk and massing of development that would be harmful to and fail to maintain or enhance local character and appearance of this rural location. The

proposal would result in a building that fails to preserve the rural character and openness of the nationally significant Kent Downs AONB and fails to preserve the intrinsic character of the countryside with the proposed dwelling more visually harmful than the existing dwelling. As such the development is contrary to policies SP17, DM1, DM30 and DM32 of the Maidstone Local Plan, the Maidstone Landscape Character Assessment (2013) the Kent Downs AONB Management Plan (2021 - 2026) and guidance in the NPPF (2021).

The Council hereby REFUSES Planning Permission for the above for the following Reason(s):

(1) The proposed dwelling, together with the change of use of land to domestic garden, associated works and domestic paraphernalia in this countryside location, would have a detrimental urbanising impact on the existing character of the area consisting of a rural landscape resulting in harm to the rural character of the area with a failure to contribute positively to the conservation and enhancement of the landscape and the nationally important Kent Downs AONB, contrary to policies SS1, SP17, DM1, DM30, DM33 of the Local Plan, the Kent Downs AONB Management Plan, and the National Planning Policy Framework (2021).
