KEMBERTON PARISH COUNCIL

Minutes of the Meeting of Kemberton Parish Council held on Wendesday 9th March 2022 at 7.30pm at Kemberton Village Hall

In attendance: Cllrs Martyn Bidgood (Chairman), Angela Blount, Phil Jones, Mary Wright, Mark Lea, Giles Greenwood. Also in attendance: Shropshire Council Richard Marshall, Vanessa Voysey (Parish Clerk) and five members of the public.

21.95 Chairman's Welcome and Announcements

The Chairman welcomed everyone to the meeting, and thanked the members of the public present for their attendance

It was **agreed** that the item on the proposal for a Solar Farm should be moved up the Agenda for discussion and incorporated into the public participation session

21.96 Apologies

There were no apologies at this time

21.97 Disclosable Pecuniary Interests

No pecuniary interests were declared at this time

21.98 Dispensation

There were no requests for dispensation at this time

21.99 Report from Shropshire Councillor

Cllr Richard Marshall notified the Parish Clerk and Chairman prior to the meeting that instead of giving his usual report he would comment within Agenda items. He also noted his apology that he would have to leave before 9 o'clock as he had an online meeting ot attend.

21.100 Public Participation Session

The Chairman, Cllr Martyn Bidgood reported that information on the proposed solar farm had been received in the post on 25th February by residents and that the Parish Council had not received prior notification. He had received comments from residents after the consultation event on 3rd March in the Village Hall and so far all have been against. He said that if the Parish Council registered an objection it would need evidence of objection from residents. He suggested setting up a Working Party to look at the issue and to frame responses to requests for Planning Permission.

Cllr James Rennison commented that the Parish Council is voted in every four years and has a mandate, if its members object to a plan that it is commenting on then there is a mandate for an objection to be registered with the planning authority. Residents will be able to register any views they have on plans

Shropshire Councillor Richard Marshall said that he would call in any requests for Planning Permission so that it would be determined by Committee. As ward member he would have 5 minutes to speak about it. He advised on the necessity of framing responses with the National Planning Policy Framework and Core Strategies including numbers relating to it. Classification of the land would be important, and evidence as to why it is not an extreme circumstance that requires use of Green Belt Land. He noted that the site suggested is on the border with Telford and Wrekin where there are SamDev designated areas for commercial purposes.

A member of the public noted that there are multiple sub-stations on Halesfield (which is where the energy would feed into). He said that it would be necessary to demonstrate that the loss to the village outweighs any benefit to Shropshire Council's Carbon Zero commitment.

Cllr James Rennison said that any objections needed an orchestrated plan of attack. If there are any contrary views, they can be put forward.

A member of the public said that the village would not succeed without engaging external help to structure a response. Being a Conservation Area would not feature, arguments would need to be about the Green Belt, the loss of agricultural land, and the visual impact, and would need to link in to policy and policy reference numbers.

Cllr James Rennison said that appointing a Consultant should be considered. There was some discussion on this point, including the possible costs, sources of funding, and the level of Parish Council reserves.

Cllr Mark Lea noted that he gets constant approaches about the use of his land for solar energy.

21.101 Proposed Solar Farm Development

It was proposed, seconded, and **resolved** to set up a Working Party to look at framing a response to the proposed solar farm.

The members were agreed as: Cllrs Martyn Bidgood, James Rennison, Phil Jones, and two members of the public present who volunteered their services.

The Parish Clerk noted that working parties are advisory bodies and that any commitment to use Parish Council funds could not be delegated but would need to return to the Parish Council for agreement.

It was proposed, seconded, and **resolved** to subscribe as a CPRE Member, at the cost of £36 (paid by Direct Debit)

It was proposed, seconded, and **resolved**, to in principle subscribe to the Solar Campaign Alliance, the requested contribution being £20.

21.102 Minutes

It was proposed, seconded, and **resolved** to approve the minutes dated 12th January 2022

21.103 Matters Arising

There were no matters arising not otherwise covered in the Agenda.

21.104 Queen's Jubilee

Cllr Giles Greenwood reported that the Village Hall has planned a Hog Roast for Saturday 4th June.

There was some discussion on the Queen's Green Canopy and tree planting, including noting the current condition of the Millennium Oak.

The Parish Clerk reported that a request for permission to put in a village gateway had been filed with Shropshire Council following the last meeting. It was noted that this permission would cost £440 in addition to the cost of the signage. There was some discussion about financial priorities, with consideration of the celebration planned for the 4^{th} June and the possible hiring of a consultant to advice on the solar panel development.

It was proposed, seconded, and **resolved** to suspend plans to put up a village gateway at this time.

21.105 Highways

It was noted that a serious accident had taken place at Kemberton Junction on 3rd March. The Chairman reported that Shropshire Cllr Richard Marshall had contacted the Police Commissioner about speed checks on this section of road.

Cllr Giles Greenwood reported that he had been contacted by residents about the poor state of Field Lane. The Chairman, Martyn Bidgood, said that he had been contacted about Grindle Road by residents who avoid using it because of its poor condition

Mill Lane towards Evelith was also noted as been in a poor state or repair.

It was agreed that the Parish Clerk should report all the above to Shropshire Council.
