Change of use of land to garden.

P3. 19/00832/REM – Land Adjacent to Summerfield, The Ridge (Adjacent Parish).

Approval of reserved matters following outline permission 16/02529/OUTD - Change of use of part of existing agricultural field to residential and the erection of 5 no. detached dwelling houses with ancillary garages, access, parking, landscaping and associated works. Matters seeking consent - Access, landscaping and scale.

The applicants have taken the decision of the WBC Western Area Planning Committee to appeal. It was agreed that the Clerk would submit extra comments to the inspector enforcing BPC's opposition to this application.

Round Table Comments:

RT1. Common Clearing.

It was agreed that the Common Clearing and litter picking event scheduled for Saturday 10th October would be cancelled due to Covid.

RT2. Covid 19 Support.
