#### **Public Session**

383/92/16 There were no matters raised.

#### **Hamble Lifeboat Station Construction Project**

52/21/15 Cllr Hand said that he and the Clerk had met with Mr Rose to discuss the wording of a joint statement regarding the Foreshore toilets, to be published in the Hamble Village Magazine, as agreed at the last meeting of the Parish Council. Subsequently it had been decided not to publish any statement.

Mr Rose was asked to update the Council on the improvements they required to the unisex toilets.

Mr Rose said that there were a lot of trades involved in this work and these were difficult to co-ordinate: Three contractors had been contacted. So far one declared the project too small to deal with, one did not attend the arranged site meeting and a further with whom a site meeting has yet to be arranged. Mr Rose said that the extra costs for full height tiling should be met by Hamble Parish Council.

Mr Rose commented that at the Council meeting of 12<sup>th</sup> September, it was recorded that the final decision regarding the suitability of the disabled toilet was in the hands of Eastleigh Borough but it appeared unlikely that the Parish Council would be getting advice from them.

The offer of advice from Eastleigh Borough Council was made by the leader, Cllr Keith House and Cllr Hand would e-mail Cllr House about this. With regard to the certificate of completion for the building, the Parish Council has not had sight of this document. The Clerk confirmed that the Council had received no information from Eastleigh Borough Council as to whether they had seen the Certificate of Completion for the project.

Cllr Cross pointed out that the legislation was quite clear regarding disabled toilets in terms of the door opening direction and the area of the interior space. This was part of the current building regulations and was the minimum standard required.

Cllr Hand asked Mr Rose to obtain a tender for the list of eight improvements the Parish Council had asked the Trustees to undertake as soon as possible, and thanked Mr Rose for attending the meeting. The Clerk was asked to arrange a meeting of the Leases Working party to discuss the situation more fully.

#### **Reports from the Clerk**

239/81/12 Hamble-Le-Rice Parish Council Secure Storage. The Working Party meeting had to be postponed as Cllr Cross was called away. This would be reconvened as soon as possible **CLERK** 

**205/61/13** Path from Well Lane to Marina Drive. This matter has not yet been re-assigned to a member of the Legal Team at Eastleigh Borough Council. The Clerk added that there may now be a charge for any work undertaken in future.

111/32/15 Eastleigh Borough Council Developer Contributions. There is no further information on this. The work at Coronation Parade is going through the full LAC.

**275/71/15** Hamble Footpath 5. The Clerk reported that the Commodore of the Royal Southern Yacht Club had written to confirm what he had stated verbally.

464/121/15 Westfield Common Information Boards. These had suffered no further vandalism and were fit for purpose. Cllr Hand proposed, Cllr Underdown seconded and all agreed, and <u>IT WAS</u> RESOLVED that this item now be closed.

233/52/16 A Neighbourhood Plan for Hamble-Le-Rice: Cllr Cohen was unable to attend the meeting to give a report. Cllr Hand reported that he had recently attended a workshop presented by officers from Hampshire County Council where the new proposals for the governance of the whole County were being outlined. They were assured that Town and Parish Councils would remain, but strongly advised that, to be effective, each needed to have a Neighbourhood Plan.

239/52/16 A Mobile Phone Mast on the Council's Property. A copy of the proposed Heads of Terms had been circulated with the papers and the Clerk had checked with the Council's Solicitors to ensure that they were not binding on the Council if they chose to accept them. He also recommended the Leases Working Party met to discuss these. Cllr Hand proposed, Cllr Hughes seconded and the majority agreed, and IT WAS RESOLVED that these be accepted.

**357/91/16** Foreshore Temporary Toilets. The Clerk confirmed that the Company supplying the temporary toilets had been instructed to remove two, although they had not yet done so.

# **Hamble Parish Public Landing Points**

**389/92/16** Cllr Underdown has recently embarked and disembarked at the public landing places on the river in the Parish, and has given the following report:

On 17th September 2016, as part of the Parish Council's policy to annually embark and disembark at all the public landings on the river in the parish of Hamble (policy 4.10b), I undertook this task.

This included the Parish Council's dinghy slipway, the public hard and the end of the footpath by the viewing point at Mercury Marshes and the quay/slipway at Mercury creek.

As was the case last year I was unable to land at the end of Footpath 5 as the project to provide a ladder and mooring ring has not yet been completed.

The Council NOTED the report and thanked Cllr Underdown for undertaking this survey.

#### **The Hamble Foreshore Dinghy Park**
