P25.97	PL/25/4596/DE - Land Between Wendover Road and Aston Clinton Road Submission of Reserved Matters (access, landscaping, appearance, scale and layout) for the Employment Land Spur Road accessed off the permitted Southern Link Road (East) 23/03195/ADP into the Employment Land Parcel pursuant to Outline Planning Permission 16/00424/AOP and approval of Conditions 16 and 17 (Landscape Scheme), Condition 19 (Tree and Hedgerow Protection), Conditions 20 and 21 (Ecology), Condition 22 (Badger Mitigation), Conditions 24 and 25 (Drainage and SUDS) and Condition 40 (Highways). This application was considered, and it was agreed to raise the following concerns regarding the SLR East Landscape & Environmental Management Plan- <ul style="list-style-type: none">• LEMP based on 2020–21 surveys; need confirmation of updates post-HS2 and CEMP assessment date.• RMA and hedgerows mischaracterised; wildlife, including Red List birds, insects, and rare butterflies, is underrepresented.• Clarification needed on reptiles, Great Crested Newts, and bat habitats, including GCN licensing and water features.• Responsibility for long-term maintenance of new planting is unclear.• Weed control methods, herbicide use, and ecological mitigation in RMA require clarification.• Site classification as “poor/derelict” and projected biodiversity outcomes may not reflect actual ecological value.
