What are we basing our objection on? (to meet the planners criteria)





Impact on our highways - Our roads are not able to cope with the significant increase in heavy goods vehicles (HGVs). This will lead to congestion, noise pollution, and more fatalities (evidence shows fatalities are higher when involved with HGVs)



Contradiction of Council planning policy - When incinerators are introduced into communities, recycling decreases. This contradicts the councils CORE Waste Strategy which identified the ambition to achieve 70% recycling or composting of all waste by 2025.



Noise - An incinerator would introduce noise pollution into our community. These concerns have been raised by residents near Sinfin incinerator at Derby



Smell - An incinerator would bring unpleasant smells into our community. These concerns have been raised by residents near the Sinfin incinerator at Derby



Impact on health - Living near an Incinerator impacts on respiratory health. Bilsthorpe has more Obstructive Pulmonary Disease (COPD) than the national and regional averages.



Impact on the Environment - Incinerators produce ash and toxins which can harm the local environment. These toxins can contaminate the food chain, particularly as Bilsthorpe is surrounded by farm land.
