16/206 – Apologies for Absence : C Kemsley -Pein, P Hooper

16/207- Declarations of Interest: None declared

16/208 – Comments from the public: A member of WCLG (Wormslade Community Liasion Group) attended and spoke in relation to the Planning Application 17/00037/WASVOVC - Variation of Conditions 2 (Scope of Permission), 5 (Operation Limits and Feedstock) and 14 (Catchment Area) of planning consent ref. 15/00090/WASFUL to modify the approved feedstock to incorporate other waste materials at Wormslade Farm, Clipston Road, Clipston, Market Harborough, LE16 9RP. They met with Stuart Homewood of Raw Energy and had visited two of their sites. One of these sites processed out of date food and the other processed sileage. The sileage plant appeared to be well run, and not too odourous or noisy. The other site which processed food waste also appeared to be well run but did create more odour.

Neither plant visited is identical to the proposal at Wormslade.

They have submitted an objection letter to the application on the basis there is now a proposal for a minimum of 50% commercial waste to be processed.

16/209 – Bollard installation on Harborough Road – proposals from NCC to deal with speeding traffic – It was **RESOLVED** to state they are not in keeping with the village and would set a precedent for bollards in other areas of the village.

16/210 – Planning: DA/2017/0722 Construction of access track for agricultural barn at Land Off Sibbertoft Road, Clipston, Northamptonshire ACTION: It was RESOLVED to offer NO OBJECTION, but to comment to check the position of the heritage site and to consider the narrowness of the road to the access track.

17/00037/WASVOVC - Variation of Conditions 2 (Scope of Permission), 5 (Operation Limits and Feedstock) and 14 (Catchment Area) of planning consent ref. 15/00090/WASFUL to modify the approved feedstock to incorporate other waste materials at Wormslade Farm, Clipston Road, Clipston, Market Harborough, LE16 9RP – It was RESOLVED to OBJECT to the above application on the basis the amendment should require a further permission to allow change of use from agricultural to commercial.
