6. TO RECEIVE A REPORT FROM THE POLICE

Crime figures from1st August to 27th August were circulated at the meeting. There were 47 recorded crimes relevant to Brandon within this time period. The same time period last year saw 51 crimes recorded; a decrease of 7%. A question was raised regarding the decrease in the number of ducks seen in the area. With no reported incidences, it was suggested the Wildlife Officer at Hadleigh be contacted.
