- 135/16 **PRESENT:** Cllrs Adam, Boswell, Brown, Childs, Mannington, Reed, Robertson, Tippen and Turner. The Clerk was also in attendance.

140/16 **FINANCE**

(a) Finance Meeting held on 19th January 2016 – Minutes of the meeting were agreed and signed as a true record.

Prior to discussing the three year plan, budget and precept for the forthcoming financial year the Clerk asked ClIrs to discuss, and agree, expenditure on items raised at Finance Meeting on 19th January. After discussion the following was agreed: The leaf blower, generator and office security would be ordered in this financial year and the resurfacing of Chestnuts footpath, Rookery Path and Southons Drive would be deferred until 2016/17 and this would be shown in the revised budget.

- (b) Three Year Plan to be agreed for 2016/17. The draft financial plan from 1st December had been recirculated with audited figures and amendments were made to the 2016/17 figures. The income and expenditure for both reserve and capital accounts were agreed.
- (c) Budget to be agreed for 2016/17. The budget for 2016/17 was amended and agreed by Cllrs.
- (d) Precept The Precept proposal was revisited and discussed in great detail by all ClIrs present and after much deliberation in was proposed, and agreed, that the Precept for 2016/17 would be £112,000. This equated to £71.35 per annum/£5.94 per month (an increase of £8.35 per annum/69p per month) per Band D property. Details of this would be placed in the newsletter.
- (d) MBC Precept form was completed and signed by the Chairman and Clerk.
