1. Shrawley Village Hall

The Parish Council are the Custodian Trustees of Shrawley Village Hall although full responsibility for controlling and managing the hall lies with the Management Committee. Parish Councillors are not allowed to be members of the Management Committee solely because of their position on the Council but may be appointed as individuals to represent other organisations within the village.

2. Land now known as Millennium Green adjacent to Shrawley Churchyard

The land was gifted to the village following the death of Frederick Horton during 1990 and the earlier death of his wife Ruth Horton in 1980. The Deed of Gift was signed by representatives of the Parish Council on or around 2nd January 1992.

3. Memorial Seat and Tree on land now known as Millenium Green

The memorial seat was erected in memory of Ruth Vernon Horton and of her husband Frederick (Rick) of the Wood House, Shrawley and who are both buried in Hanbury churchyard. They were kind and generous friends to the people of Shrawley and their deaths marked the end of an era in the parish.

The memorial was paid for by donations from Shrawley Parish Council, Shrawley & District Royal British Legion, Shrawley Fete Committee and private donations from the parishioners and friends of Shrawley Village. It was dedicated on 3rd October 1993.

The memorial seat and tree are covered under the all risks section of the Parish Council's insurance policy which has a total sum insured of £10,000.

4. Millennium Obelisk

Shrawley commemorated the Millennium with an obelisk and a time capsule containing articles appropriate to the date. The obelisk is covered under the all risks section of the Parish Council's insurance policy which has a total sum insured of £10,000.

5. Village Barbecue

The barbecue was acquired in July 2012 for use within Shrawley and neighbouring parishes through the Malvern Hills District Council's Ward Councillor award scheme at a cost of £447.75 plus VAT. It is covered under the all risks section of the Parish Council's insurance policy which has a total sum insured of £10,000.
