The internal audit was carried out by undertaking the following tests laid out in the Annual Return for Local Councils.

- Checking that complete accounts have been properly kept throughout the year
- Checking sample payments to ensure that the Councils financial regulations have been met, payments are supported by invoices, expenditure is approved, and VAT is correctly accounted for
- Reviewing the Council's Risk Assessment to ensure adequate arrangements are in place to manage all identified risks
- Verifying that the precept request resulted from the proper budgetary process.
- Checking income records to ensure that income has been received, recorded and banked and that all VAT is accounted for
- Checking that salaries were paid in accordance with this authority's approvals, and that PAYE and NI requirements were properly handled
- Checking the accuracy of the asset register
- Confirming this authority met the exemption criteria when declaring itself exempt from a limited assurance review
- Checking the accuracy and timeliness of periodic and year end bank statements
- Year end testing on the accuracy and completeness of the financial statements

I can conclude that from the sufficient evidence given by means of the documents provided, this Council maintains adequate and effective internal controls, its' affairs are properly conducted and its' objectives were achieved throughout the year to a standard adequate to meet the Council's needs.
