County Council:

The devolution bid progresses with the Mayor elections scheduled for the spring.

Cllr S Pashley asks whether the speed limit through the village can be reviewed in line with the proposed reduction in Torworth taking the limit down from 40 to 30. Cllr Quigley to raise with highways.

Cllr S Pashley raises the issues of potholes on London Road and Cllr Quigley to raise with Highways

4.1023 Village Hall & Playing Field:

The owners of the Ye Old Belle have pledged £2k towards the playing field equipment.

The playing field quotes are reviewed, and the Creative Play Active Trail 8 and the swing equipment is decided upon. Total spend of £10k ex vat is agreed upon dependent on donations and grants being received.

Cllr S Pashley to cut the grass in the playing field if the weather improves.

Cllr S Pashley and Cllr C Fraser to walk around the playing field to assess for any tree damage.

The Village Hall charity Trust is discussed, all to read roles and responsibilities and to decide on how to progress the responsibilities in January.

A new boiler quote of £3k has been received. It is resolved to progress with the works. Cllr C Fraser to action the works with the contractor.
