Cllr. Bill Bendyshe-Brown, Chairman of Wycombe District Council attended the meeting. He gave an overview of Wycombe District and its employment position. The district has a good employment rate and unlike other districts, only 9% are employed in the public sector. By 2013, the new direct rail line to Oxford via High Wycombe will be in operation.

The budget restrictions have meant some sacrifices to services, and year 3 of the budget will be when cuts begin to bite.

b. Budget 2010/11

Mr Fitchew gave an overview of the budget setting meeting held on Tuesday 7th December 2010. Fees and hiring charges will not change except the hire of the Chapel which will increase to £50. There will be no change in salaries, wages and contractors' fees. The capital expenditure will be for levelling of a new area in the burial ground (£2000), a guard for the chapel window (a further £550 to add to the £1000 carried forward from this year's budget) and a further £500 towards the chapel toilet. It was recommended that we request a Precept of £39,500. (current year is £39,573). This will be ratified at the January parish council meeting.

137/10 PAVILION/RECREATION GROUND

a. Tree Works

Three quotes for the crown reduction to the lime trees were sought, but only two were received..It was agreed that the tree works to the limes should be undertaken by Bartletts.. Permission will be needed as the trees are in a Conservation Area. It was hoped that these works could be carried out in late winter.

138/10 BURIAL GROUND

a. chapel

Money has been agreed in the 2011/12 budget for the investigation works for the provision of a toilet at the chapel, and the Amenities Committee have pledged money from their budget. .

The total cost of the chapel toilet is estimated at £12,000-£14,000 and if this is to proceed grant funding will be needed for the bulk of the cost.

b. Fly-tipping

The recent fly-tipping is being investigated by Bucks County Council and evidence found in the pile may be used to investigate this further.

At the Allotment holders' meeting in November, concern was raised regarding the plot near to the car park which is not being cultivated but is used as a storage area. It was agreed by the Parish Council that this tenant shall be given notice to quit the plot .
