- 87.2** Further Planning Applications Received since date of Planning Committee for decision or referral to Planning Committee

- a) **MC/21/3347 15 Sedley Close Cliffe Woods Rochester Medway ME3 8HE**
Construction of a two-storey extension to rear together with a single storey extension to side. Cllr FH informed the council that there has been one objection from a neighbour.
- b) **MC/21/3356 Plot 6 Land West of Merryboys Farm House Cooling Common Cliffe Woods ME3 7TP**
Construction of a 5-bedroom detached dwelling with detached garage and associated landscaping
- c) **MC/21/3360 Land West of Merryboys Farm House (Plot 1) Cooling Common Cliffe Woods ME3 7TP**
Details pursuant to condition 6 (Boundary Treatment) on planning application MC/17/3572 for Outline application for six self-build detached houses with all matters reserved except access and landscaping.
- d) **MC/21/3498 Plot 66 Land at Town Road Cliffe Woods Rochester Medway ME3 8JX**
Application for non-material amendment to planning permission MC/18/2961. Amendment to plot 66 from weatherboarding to full brick

- a) **Trenport Land Cliffe** –No Planning submission yet. There is a risk of this site being added to approved sites in the Local Plan because of removal elsewhere.

- b) **Simpkins- MC/19/2836 (MC/16/3742)** Remaining reserved matters (appearance, landscaping, layout, and scale for the 50 Retirement homes (approved on appeal at outline stage) refused by Medway Planning – appeal to be decided on written representations – awaiting update. (St Helens Meadow). A further application received on the site MC/21/3380 Outline application with some matters reserved (appearance, landscaping, layout and scale) for construction of nine detached houses. Cllr FH proposed that more information was needed before a decision could be reached, seconded by Cllr RL- **ALL AGREED**
- c) **MC/21/1287 Redrow(Gladmans) site West of Town Road** – Changes have been made following representations – 138 Private/48 Affordable, 184 Total (was up to 225), 3 Storey reduced to 2.5, no pedestrian access through Ladyclose/Mortimers.
- d) **Esquire- MC/21/1694 (Orchard) South of View Road** – No further information or date for decision.
- e) **Draft Medway Local Plan** – awaiting update as publication of Draft and Public Consultation has been postponed to late February 2022.
