63/17 Highway and Amenity Items:

- a) Streetlight Albion Terrace, Craven Arms: The Clerk reported that due to the column being badly cracked there is a requirement to replace the Streetlight in Albion Terrace Craven Arms at a cost of £1,008.34 plus VAT. It was proposed by Cllr D Evans seconded by Cllr N Carter and agreed by the Council that an order be placed with E-on for the replacement of the Streetlight at Albion Terrace Craven Arms.
- b) **Highway Repairs:** Cllr N Carter reported on the highway matters that he had reported directly to Highway England and Shropshire Council Highways these included the damaged trails by the Craven Arms Hotel which had now been repaired.
- c) Parking of For Sale Vehicle in Layby adjacent to the Old Post Office The Clerk was asked to refer this matter to Highway England.
- d) **Christmas Lights Working Group** Cllr D Evans reported that the Christmas lights would be opened on Friday 24th November 2017.

- e) **Purchase of Bus Shelter** for installation on the footpath adjacent to Tuffins Supermarket Craven Arms. The Clerk reported that the cost a Bus Shelter would be £3294 however a grant of 75% would be payable from Shropshire Council leaving a total of £775 to be approved by the Town Council. Appropriate permission had been obtained from Highways England and Tuffins Supermarket had no objection. It was proposed by Cllr R Conway and seconded by Cllr D Evans and agreed by the Council that an order be place for a Bus Shelter to be sited adjacent to Tuffins Supermarket Craven Arms.
- f) **Play Equipment** The Clerk referred to the Play Area and Skateboard Annual Inspection report and the need to undertake repairs to some of the skateboard obstacles. It was suggested that consideration in the future may need to be given to the replacement of the equipment and that the Clerk obtain appropriate costs.
- g) **Hedge** The Clerk was asked if the hedgeway behind the MUGA could be trimmed this will be reported to Shropshire Council.
- h) **Car Parking** Cllr D Evans referred to the problem of car parking along Newington Way when various events are held at the Community Centre and if part of the land of the old Play Area could be converted to a car park. This matter will be referred to the CAPFA Committee.
- i) **CCTV** Cllr M Trafford referred to grants for CCTV the details of which he would forward to the Clerk.
- j) Corvedale Road Picnic Area/Car Park Cllr N Carter suggested that the height restrictor above the gateway to the picnic/car park should have appropriate warning reflectors and the height of the restriction.
