Minutes of Woore Annual Parish Council Meeting

23023 Welcome / Present, Apologies and/or absent

Apologies were received on behalf of Cllr Blake due to continued illness and from Cllr J. Higgin due to personal commitments. No apologies were received prior to the meeting from Cllr R. Aldcroft (Shropshire Council). It was unanimously **resolved** to accept all apologies.

23024 Declarations of Disclosable Pecuniary or any other Interests

Declaration of any disclosable pecuniary interest in a matter to be discussed at the meeting and which is not included in the register of interests. Members are reminded that they are required to leave the room during the discussion and voting on matters in which they have a disclosable pecuniary interest, whether or not the interest in entered in the register of members' interests maintained by the Monitoring Officer. 22025 Requests for Dispensations of DPIs

No requests were made.

23026 Open Forum: to last no longer than 15 minutes

A member of the public raised the road sign at Irelands Cross junction which has been knocked over for the third time in recent years. The Chair noted this would be reported to Shropshire Council. Noted also was the 2no streetlights still out of order at Crossways. Concern was raised that the lights came on during the thunderstorms last week and this could indicate an electrical fault. Councillors raised also the growing number of resident complaints over the brightness of the LED replacement bulbs. The Chair advised that Shropshire Council had responded to request concerns be directed to the streetlights team via the Fix My Street portal www.fixmystreet.com.

The Chair noted that summer planting was now complete throughout the parish, with thanks to the Clerk, Cllr Higgin, volunteers and Westholmes Nurseries.

It was noted that the MVAS was not restored in position at Crossways.

The Parish Council was approached by a resident regarding land Newcastle Road, with interest to whether this could be used for additional burial ground. Councillors noted that it is the responsibility of Shropshire Council to liaise with the Church regarding additional requirements for burial grounds.

The Chair noted that the Friends of Woore School Summer Fete will take place on the school grounds, Saturday 8th July, 12noon-2pm.

23027 Approval of the Minutes of the Parish Council Meeting held on 15th May 2023 (Local Government Act 1972, s12p41(1)).

It was unanimously **resolved** to approve the minutes of remote meeting 15th May 2023.

The Chair noted that graffiti on the children's play area and various other points throughout the parish still needed addressing.

It was noted that the resident struggling with noise complaints concerning dogs barking reported significant issues and no response from Shropshire Council. The Clerk agreed to contact Cllr Roy Aldcroft as Ward Councillor.

Cllr Carter noted a visit to Audlem Road Village Green to review the tree surgeon quotes. Further work and secondary quote to be sourced.

The Chair noted that Helen Morgan MP has thanked the Parish Council for its contribution to her comments in Parliament reference social housing in rural Shropshire.

The Clerk noted concerns with the new Lengthsman contract, specifically lack of communication with the provider. The Chair/Clerk to provide update in due course.

The Chair noted disappointment at communications with Shropshire Council regarding CIL payments for FY22-23, specifically, payments relating to developments for Land on Audlem Road. The Chair agreed to action this.

Victory Hall

Committee meeting took place on 19th June

- This was the first meeting of the new Committee following the AGM in May

- There is a new treasurer (Kieron Ryan) who is getting to grips with the handover from John Parkes, bank mandate also being sorted out (this was completed on 20th June)
- Bookings / payments being monitored, Yoga is now the highest revenue regular hire
- Film Nights 15th July, 9th September, 14th October (none for August), there may be a quiz instead of a film in December.
- Community Café 23rd June, 21st July, 22 Sept, 27th October (none August)
- Hall is reserved for any D Day 80th anniversary events around 8th June 2024 (to be discussed at next meeting)
- November 2025 will be the Hall's 75th anniversary so should be celebrated (the 70th was in covid)
- HS2 Grant new subcommittee formed, the application will be completed asap
- Inventory to be done over the summer
- New stage curtains to be priced up (from donations given last year which were provided for specific purposes)
- If the Parish Council were to purchase a Coronation bench at some point, the Hall would be happy to "host" it / them
- Next meeting 17th July

Footpaths

Discussion took place regarding numerous overgrown hedges within the Parish. The Clerk agreed to write to home owners.

Community Speed Watch

Cllr Hamilton noted that 2 new volunteers have now been fully trained. Coordination of volunteer availability has been difficult in recent weeks but activity continues.

23032 Section 137 Grant Application: to consider the application for a grant of £250.00 from Woore District Vegetable & Produce Show towards the 2023 show.

Councillors referred to a grant application circulated prior to the meeting by the Clerk. Discussion took place. It was **resolved** unanimously to support the application for £250 towards the 2023 show costs.

23033 Woore Place Plan: the Chair to provide an update on the review of the Woore Place Plan.

The Chair noted a meeting with Lucy Roberts, Shropshire Council Place Plan Officer is to take place at the Victory Hall, 2.00pm 28th June. Chair, Vice Chair and Clerk to attend, update to be provided in due course. The Chair has communicated with most local groups/organisations on their priorities for the Place Plan.

23034 HS2: the Chair to provide an update on all matters related to HS2.

The Chair noted that Shropshire Council has granted approval of the lorry routes and a subsequent response to the Shropshire Star had been provided on behalf of Woore PC noting the Parish Councils disappointment. Land acquisitions continue despite the halt on all HS2 related groundworks.

23035 Finance:

The Clerk noted this was complete thanks to Cllrs Hamilton and Goodman, who stepped in on behalf of Cllr Higgin to cover personal commitments. The Clerk noted that a payment of £ 1,581.93 had been made by HMRC for VAT period 1st April 22-31st March 23. HMRC yet to respond regarding overpayment. Clerk to note refund of £855.16 will be requested at some point and should be considered for contingency in FY 23-24 financials.
