## 115 Public Forum

Member of the public, asked about the Parish Council Annual Report, a copy of which had been picked up at the Post Office. They wished to commend the Council for producing this document which was very informative. Clarification sought on what was meant by "best value" as this seemed quite a vague term – several instances were cited, whether this be lowest cost, past performance or materials used and the maintenance which may be required in the future, depending on the particular matter under consideration.

A member of the Collingham Angling Association came to inform the Parish Council about the Hydropower scheme approved by NSDC for Cromwell Weir, which has now been quashed in the High Court as the decision was deemed unlawful and had been made under delegated powers. The Angling Association would like the support of the Parish Council should a future application be submitted to protect the 300 pegs from the weir to Besthorpe that would be affected by such a proposal. a) Remedial actions to the wildflower meadow – The original contractor let the Parish Council down badly and whilst the best effort of the Parish Councillors have resulted in the area being unseeded this year, given the current temperatures and lack of water the seeds would all have failed and had to be redone in the autumn. There is now a local contractor onboard and working with the Council to rectify some of the issues. The local Rotary are meeting with the Clerk tomorrow (Friday 27<sup>th</sup> July) to see if they can provide some manpower to assist with the seeding and possible planting of bulbs at the appropriate time.
