Andrea Muckley and MP Josh Newbury all exchanged details with the residents and promised to enquire about the service. Cllr. Andrea Muckley advised the resident to get as many other parents on board as possible, also speak to the Safe Guarding Officer and Head Teacher at the school for their input. She reported that she was constantly pursuing the bus services in the rural parishes, but was aware that if they altered a service to the good of the residents they reduce a service in another parish.
