Public Question Time

No members of the public were present. District and County Councillors were present and a member of the press.

1. Apologies for Absence – Cllrs Bye, Eldridge, Gyngell, Howell, Cllr M Palmer and Ratcliffe.

2. Disclosure of Interest

Cllr Ormonde-Butler declared a personal and prejudicial interest in the Cricket Ground item.

The Chairman informed everyone that the Clerk will be reviewing the Standing Orders and will be changing the running order of the agenda, to allow the District and County Councillors and the PCSO to speak earlier in the meeting.

3. Minutes of the Council Meeting held on 20 May 2014. Cllr Jessop proposed approval of the minutes, seconded by Cllr Sydes – agreed.

4. Matters Arising from Previous Meetings

The Clerk advised that pending confirmation from the Monitoring Officer the **Councillor Vacancy** would continue to be advertised as part of the ongoing exercise. The Clerk advised that the work to drain the **cricket ground** had commenced using the agreed contractor and that the meeting with **Battle Abbey** about the sports hall will take place on 4th July.

5. Correspondence & Communications

- (1.) Concorde 1066 Cllr Furness was proposed by Cllr Jessop and seconded by Cllr Fisher to be the Council's representative on the Concorde 1066 Committee and that an extra meeting would be needed to discuss the event once firm information is known.
- (2.) Shaws Funfair the change of date from September 2014 to 30 June to 7 July was agreed subject to the usual conditions.

6. Grant Application Kent, Surrey and Sussex Air Ambulance

Cllr Fisher proposed approval of a grant of £250 seconded by Cllr Jessop.

7. Annual Audit and Return. Council agreed to hold an extra-ordinary Finance and General Purposes Committee Meeting on Thursday 26th June at 6.30pm to approve the Annual Return with full delegated responsibility from Council.

8. Process for Grant Applications

Council agreed that a co-ordinated approach to future grant applications is needed and that this will be taken forward by the Finance and General Purposes Committee.
