

What is a Neighbourhood Plan?

A **Neighbourhood Plan** is a new way of helping local communities to influence the planning of the area in which they live and work. It can be used to:

- Develop a shared vision for your neighbourhood
- Choose where new development should be built
- Identify and protect important local green spaces
- Influence what new buildings should look like.

Different issues need different planning responses. There might be other plans that meet your needs.




Strategic Environmental Assessment

- Strategic Environmental Assessment (SEA) may be a legal requirement if the Neighbourhood Plan is likely to have significant environmental effects.
- And Habitats Regulations Assessment
- Keep screening the plan.
- No statutory requirement for Sustainability Appraisal (SA) but good practice for plan-making. A plan with integral SA will easily be able to show how the plan seeks to deliver sustainable development
- SA should influence the plan.






