Variance - £8,357

£290 - A large portion of our annual expenditure is on the cricket pitch and field. During the pandemic in 20/21 no cricket matches were played, therefore once cricket matches re-started in summer 2021 more expenditure was required to bring the pitch back up to the standard required.

£734 - extra maintenance required to the tractor.

£251 - extra expenditure on grass seed and loam.

£715 - our village May Tree had to be felled and a new one planted. Donations of £600 were made to the Parish Council at the beginning of 22/23 that were not taken into account against the cost of the tree at the end of 21/22. - One-off expense.

£880 - the bus shelter and telephone box required one-off repairs.

£2,265 - a defibrillator cabinet and 2 defibrillators were purchased. This cost was offset by grants received of £1,885. - One-off expense.

£500 - a speed gun was purchased for our community speed watch programme. - One-off expense.

£5,202 - new playground equipment was purchased. Offset by a £4335 grant in 20/21 - One-off expense.
