Village Hall

The scaffold has been erected - there has been one accident a member of the WI tripped on the path getting round the scaffold – several concerns were raised about the scaffold – part has been erected on Mr and Mrs Godfreys land before gaining permission, the scaffold does not have any warning tape on it, and the fire exit is partially blocked. Mr Bevens informed the PC that a party is booked for Saturday and they can't change the venue – clerk and chairman to make sure the fire exit can be used. PC agreed from Monday 12th February the Hall will be closed until further notice

The chairman and clerk will meet with Mr Garratt to bring up these points and talk about the interior of the Hall, to see if things need removing from the walls or covering up and if the builders need to use the kitchen or toilets

The defibrillator is being wired into the phone box this week, the sign has now been put up

The second defibrillator will be put up by the hairdressers on Radley Road and wired into the shop

The new dog bin has been ordered and will be put up in the overflow car park at the Waggon and Horses
