23/00627/OUTMAJ Institute For Animal Health High Street Compton Newbury RG20 7NN - Section 73: Variation of Condition 2 (Demolition Phasing) of application 20/01336/OUTMAJ

23/00794/COND Institute For Animal Health, High Street, Compton, RG20 7NN -Application for approval of details reserved by Condition 18 (Contaminated Land Investigation and Remediation) Part b)-d) of planning permission 20/01336/OUTMAJ

Resolved: To object to both applications and submit the following response:

Again, Compton Parish Council has paid for professional advice to ensure the recent applications are legally compliant and follow due diligence; and after hosting an additional Planning Committee Meeting, the Parish Council hereby submits the following comments, with the <u>request that they are acknowledged with a reply</u> <u>aligned to the national planning framework</u>.

23/00794/COND Application for approval of details reserved by Condition 18 (Contaminated Land Investigation and Remediation) Part b)-d) of planning permission 20/01336/OUTMAJ

Dealing with the remediation section of Condition 18, the application broadly ties in with the information provided for the other parts of condition 18. It is a detailed document which appears to understand and appropriately deal with the expected remediation. However, there remains some question about enforceability, Compton Parish Council requests visibility of the assigned enforcement plans.

23/00627/OUTMAJ Section 73: Variation of Condition 2 (Demolition Phasing) of application 20/01336/OUTMAJ

Whilst on the face of it, this is a simple change to a phasing plan, the effect of a s73 application is to grant a whole new planning permission. <u>Compton Parish Council</u>

requires confirmation that the Planning Department is satisfied that all the documents on which it bases its decision have been updated and considered. Compton Parish Council is surprised that current evidence is a **brief** cover letter and replacement plan, whereas the Council's requirement document indicates that an **extensive** list of evidence might be appropriate, and given that this remains a contentious site, with a multitude of risks which come out of the demolition and remediation of the Site, **Compton Parish Council would expect reports to be produced to justify the changes.**
