d) A57 Crossing

The Chairman reported that he had noticed a flashing road sign on entering the village of Tuxford, which indicates the speed of a vehicle as it enters the village. The possibility of having a similar sign at Dunham on Trent was discussed as to whether it would be beneficial and where it would be best placed. The Clerk will write to the Highways Department to find out who supplies the sign and to what cost. **Action: M. Annable**

e) Land Registry

Information had been received in the post stating that Parishes should ensure that their land is registered. Cllr Barden suggested that it would be worthwhile looking into this matter because of the Enclosure Act Award. The history of the Village Hall needs to be accessed to shed further light on the "gift" of land at the time the Hall was erected, before a decision on registration is made. **Action: Cllr M. Matthews**

f) Playgroup

Cllr Barden discussed the dwindling numbers in the playgroup because the State school now takes children at four years old. Although the Playgroup had began an intake age of two years old to balance the shortfall, Cllr Barden said this could potentially become a problem, leading to closure of the Playgroup. The Clerk had made contact with CCIIr John Hempsall to enquire on the current situation with the bus shelter. He informed the Clerk that the width of the path originally planned for the bus shelter was not wide enough. The alternative was to position the bus shelter on the opposite side of the road but this would have to be 60 yards away. CCIIr Hempsall will update the Clerk with any further developments on this matter. The Chairman noted the comments from CCIIr Hempsall and stated that the Planning Department at Notts County Council had identified a piece of land at the end of Cartwright Close but nothing further had developed as a result of this.

c) Footpath - Crocketts Hill

The Clerk had written to the Highways Department to clarify the cost of providing a footpath. The reply was read out to the meeting. The cost quoted was £100,000 although there was no detailed estimate supplied. This amount seemed very high and generated dissappointment, additionally it was felt that there had been no mention of a cheaper solution. The Clerk will write to the Highways Department in response to the estimate. Action: M. Annable

d) Motorcycle Complaint

The Local Beat Manager PC Bailey attended the meeting in response to the previously reported motorcycles in the area. He informed the meeting that he covers 21 villages in Bassetlaw and the motorcycles cause nuisance to

most of them. The Police are not allowed to chase the culprits for Health & Safety reasons. The only good deterrent they have is to confiscate the vehicle under Section 59, this implies a recovery charge of £100. The problem with enforcing this deterrent is that the culprit has to be identified first. PC Bailey advised that anyone seeing persons leaving their property in use of the motorcycles should call the Police.

PC Bailey also commented at the rate of crime in Dunham on Trent in comparison with other village about the same size. He said that 12 crimes had been reported in 3 months most of which were theft and burglary. Although there were no major crimes, the figures were considered to be high and a contributory factor maybe that the village is on a main route. PC Bailey informed the meeting of a New Style Policing called Safer Neighbourhoods which will involve the District and Parish Councils in the prevention of crime.

The Chairman thanked PC Bailey for attending the meeting and for the information provided.

e) Employee Issues

A letter was presented to the meeting indicating the amount of mileage incurred by the Litter Picker, Colin Gaisford. He had quoted a monthly mileage of 42 miles a month minimum. After discussion it was decided that mileage should be paid at 40p per mile. The Clerk will draft a new claim form which will incorporate mileage payment.

Public Discussion

Cllr Matthews opened the meeting by welcoming all present and asked each representative of the Parish villages to report on any issues in need of discussion at the meeting.

DARLTON

Cllr P Lyons reported that as always, there is too much through traffic in Darlton, and this will continue to be a problem for the village.

Cllr Matthews asked about the Play Area, Cllr Lyon said that the area was in regular use and had been maintained and that a small amount of woodchips had been laid in some areas. The Parish Litter Picker, Mr C. Gaisford said he had walked round the play area and was not satisfied with the standard of maintenance as he had discovered protruding nails on the fenced areas of play. In his opinion the staves of fencing should have been placed on the outside of the play areas. Mr Gaisford also remarked about soiled nappies being placed in the litter bins.

RAGNALL

Cllr M Barden was asked about current issues in Ragnall and reported that generally there were no problems. She made a comment about the footpaths that need to be made wider and said this was on-going. The Clerk informed the meeting that a request had been made by Cllr G Saville to place a bus shelter in Ragnall for the school children, this request is relatively new and is currently being dealt with.

DUNHAM ON TRENT

Cllr C Dixon reported a serious issue regarding the hedge at Jubilee House. He admitted that he had cut the hedge back to allow pedestrians to walk safely along the pavement, but unfortunately the owners of the property were pursuing legal action against him, charging him with criminal damage. Cllr Dixon had received several letters of support from residents in the area.

Mr C Gaisford raised the issue of Land Registry and requested that the Parish Council ensure that the land owned by the council is properly registered. Cllr Matthews felt that the land surrounding the War Memorial is registered, however, this

will be checked and other areas will be registered in due course. He reported that the hedge surrounding the War Memorial has been cut in line with the adjoining hedge.

Mr Gaisford questioned the income from the Reptile Gardens and asked what the income is used for. Cllr Matthews informed Mr Gaisford that this money is paid into the Parish Council account. Mr Gaisford was concerned that the proprietor of the Reptile Gardens sublets and suggested that the Parish Council should increase the rent because of this.

Mr Gaisford then reported several overgrown hedges in the Parish, namely, The Green in Dunham on Trent, 2 Low Cottages at Fledborough and Horseshoe Cottage at Darlton. He also reported that some areas were being used as dumping grounds, namely the end of Horne Lane, Dunham on Trent and Ragnall Pumping Station. These issues need to be addressed and it was suggested that they are published in the next issue of the Trentsider to bring about public awareness in the hope that the problems are dealt with. It was agreed that rubbish collections by Bassetlaw District Council are provided on a regular basis to prevent these problems occurring.

Mr Gaisford wished to clarify the position of responsibility for sweeping the footpaths of the Parish. The Clerk had sent information to Cllr I Atkinson about this issue and he in turn will communicate with Bassetlaw District Council and inform the Parish Council with the outcome of his enquiries.

Mr Gaisford highlighted the problems surrounding Cocketts Hill in Dunham on Trent. He had arranged a meeting with Principle Officer Mr R Statham from Nottinghamshire Highways Department and walked around the Parish with him to point out problem areas. Cocketts Hill was included, but unfortunately the level of traffic passing by at the time of the meeting was low and the true dangers were not apparent.

Mr Gaisford asked about the situation with the old NCC building. This was discussed by all present. The building has an asbestos roof which would need specialists to remove it and this would prove costly. Additionally, it is not clear who owns the land that it stands on.

Cllr Matthews asked Mr Gaisford if he had any further comments to make about the Parish Council, Mr Gaisford was pleased there had been an increase in the annual Churchyard Grant.

The Chairman declared the meeting closed at 7.30 pm.

The Clerk read out a letter intended to send to Mr Gaisford for the opinion of all present at the meeting which clarified the situation, this was approved. Further discussion lead to a decision that the Contract for the Litter Picking position will go out to tender at the start of the new financial year in order to prevent this problem occurring again. The matter concerning responsibility for sweeping footpaths is still on-going.
- e) <u>Jubilee House, Dunham on Trent</u>

 Cllr Matthews read out a letter from Mr McCue the owner of the house. The letter asked several questions about who had cut the hedge and asked for a reply within 5 working days. The Clerk had replied to the letter this was also

read out, explaining that the Parish Council had no connection with this and no complaints had been received about the hedge. Subsequently Cllr Colin Dixon had admitted that he had cut the hedge back as it was encroaching onto the footpath. The owner was charging Cllr Dixon with Criminal Damage to his property. PC Bailey said that this seemed to be overreacting but technically the charge could apply in this case. Cllr Dixon passed several letters of support over to PC Bailey to present to the CPS. PC Bailey commented that the situation could have been resolved by contacting the Highways Department for them to cut the hedge back as it is their land. Cllr Barden suggested that the Parish Council also send a letter to the CPS in support of Cllr Dixon. Action: M Annable

Lorries travelling through the village were causing a problem, particularly by two companies named Cannute and Lafarge. The drivers mount the pavement at the bends, PC Bailey said this is because of the size of the vehicles and to prevent them crossing over to the other side of the carriageway. Cllr Dixon said that the drivers can be seen speaking on walkie talkies and not giving full concentration to their driving. The Clerk was asked to write and bring this to the attention of the companies involved. **Action: M. Annable**

d) Highways Parish

Cllr Matthews asked PC Bailey for comments about speed limits in Rural areas. PC Bailey said that because of the continuing speed issues through villages local Parish Councils can now elect volunteers fro the communities to detect the speed of motorists. They monitor traffic flow and compile a list of registration numbers and hand them in to the police. However, this can become personal if people are known to each other, therefore it is better that people are chosen from other areas to do the task. Cllr Atkinson spoke of the speed limits at the school entrance and said that this should be reduced to 20 mph as in other areas.

- g) LIVES (Lincolnshire Integrated Voluntary Emergency Service)

The Laughterton LIVES Group Co-ordinator, Mr Richard Elliott gave a presentation on the First Response operations currently in force in the district. Founded in 2003, he informed the meeting that the cost to run the service amounts to £2002 per annum and that they rely on funding from all Parishes involved. He requested that the Parish Council give a donation towards the cost and suggested a figure of £250 per annum. He also asked if the Parish Council could provide a map of the area to aid the Response Team locate any calls they may receive in this district. Cllr R James agreed to supply a map.

The objective of LIVES is to get a trained person to the scene quickly in response to a 999 ambulance call. The responder must be fully trained and able to reach the incident in no more than six minutes, because of this the Laughterton Response Team would only be able to attend incidents in the parish of Dunham on Trent. In view of this the Chairman was cautious about giving a donation at this particular time stating that this would be unfair to the other Parishes under our remit. Cllr Barden said that because the Response Team had attended incidents in Dunham on Trent we should consider some type of help towards the running of the service so that the help may continue. Further information is necessary regarding provision of the service to Darlton, Fledborough and Ragnall before a decision can be made. The Clerk will make enquiries prior to the next meeting. Action: M. Annable

h) School Governors Report

Cllr L Sharpe informed the meeting that the Police have visited the school and are aware of the speed issues outside the school entrance. They have also issued on the spot fines to motorists who have used illegal manoeuvres outside the school entrance. b) Bus Shelter, Laneham Road

A letter received from Karen Emery (Technical Officer, Passenger Transport) was read out by the Chairman. d) Speed Limits

A reply had been received from Mr R Statham (Principal Customer services Officer) regarding the speed limit enquiries from the previous meeting. The A57 running through Darlton will be included in an assessment in the New Year. As regards to 20 mph speed limits, the County Council are currently experimenting with two sites within the County to see how effective they are helping them to formulate a policy for possible introduction of new limits.

e) LIVES (Lincolnshire Integrated Voluntary Emergency Service)

The Clerk had made enquiries via EMAS (East Midland Ambulance Service) as to what provision of First Responders existed in the area. From their Headquarters was passed onto a Shaun Keown a regional co-ordinator who was not aware of any cover at the present time. He spoke of what is entailed to formulate a group of responders and will forward literature to the Clerk.

The Chairman had searched back into old records from 2003 and found that a group called RADAR based at Rampton had approached the Parish Council for help with funding. The areas covered by them at that time included Dunham and Darlton but

not Fledborough and Ragnall because of this the Parish Council shelved the idea. The Clerk will make enquiries to find out if RADAR still operates in the area. Cllr M Barden said that if Fledborough and Ragnall are not included in their catchment area this should not deny Dunham and Darlton the service. Action:M. Annable
