12.1	Councillor K. Salter explained that the last grant applied for, for the bollards had	
	been refused and believed that there maybe more weight to get a grant for a	
	drone. The cost of an automatic barrier was high, and most grant distributors had	
	concerns over a member of public manually shutting the barrier due to health and	
	safety.	
12.2	The Clerk explained that there would be a need to establish a policy for if the	
	Drone was used outside of the village as the Parish Council can only spend money	
	within the village. Cost would have to be reimbursed from the Parish where the	
	Drone was used, and the other Parishes would have to sign up to the scheme and	
	accept the terms.

	were in place. The drone would encourage more police presence it was felt also	
	especially as when it was in use, they would need to be present.
