48.15 Apologies for Absence: District Cllr Dibden

49.15 Declarations of Interest regarding Agenda items: Cllr Acciarri declared a non-pecuniary interest in any matters concerning Fir Hill

50.15. County and District Councillors Report:

County Cllr Huxstep reported on the Extraordinary Meeting of WCC, called to determine the number of councillors for divisional distribution with the aim of reducing 57 councillors to 45. It was decided the number should remain unchanged. Proposed boundary changes would mean that the Meon Valley ward could be over represented therefore the division will have to expand to meet numbers of electors per councillor (2200 electors +/- 10% by 2020) The Meon Valley division would be represented by 3 councillors.

Broad Band Wave 2. The program is late but certain, implementation planned 2016-2018. BT is having difficulty obtaining sufficient outreach teams.

Parking by school parents in the Park - Cllr Huxstep proposed to contact Droxford Junior School to discuss the school travel plan as the first step to address the problem.

WCC Cllr Dibden was unable to report due to convalescence.

SDNP14/04418/FUL Upland Park, Garrison Hill, Droxford SO32 3QL

Minutes of the meeting held between SDNP and Eider Homes had been circulated prior to the meeting - SDNP maintained there are 2 main principles to be established. 1) Hotel use – sufficient evidence to justify the loss. 2) Location outside the settlement boundary – justification for why 100% affordable housing or a rural exception scheme is not viable in the location.

Subsequently a letter from the owner of Fir Hill had been received, informing the Council an easement had not been granted for Eider Homes to provide a footpath over Fir Hill land to link a development to the village. In view of the continually changing planning status of Uplands there was no intention to do so.

The Council agreed that although the policy for developing 100% affordable/rural exception homes outside the boundary of a parish is clear, they regretted the way in which the application had been handled by SDNP. That documentary proof of lack of market demand for a hotel was accepted but it was questioned how much local demand there was for 100% affordable housing. It was agreed

Cllr Melson reported that discussions with Highways are ongoing. Cllr Foster said that enquiries were being made into provision of a traffic mirror at the junction of Midlington Hill with the A32.

58.15 Parish Matters:

The Big Tidy Up: Saturday 25 April — Cllr Melson said that Highways prohibit litter picking on trunk road verges. Volunteers will be briefed on health and safety matters at the start, and routes allocated. A risk assessment had been prepared. Hi-viz vests, litter picking sticks and latex gloves would be handed out. Disposal of bags of rubbish had been arranged. She hoped there would be plenty of volunteers — David Broughton had sent apologies, but will litter pick on a regular basis. Cllr and Mrs Acciarri litter pick regularly, as do others from time to time.

- 59.15.1 Annual Parish Meeting 21 May. The theme is the Village Design Statement; SDNP officers Chris Paterson (Communities Lead) and David Boyson (Historic Buildings) have agreed to speak at the APM.
- 59.15.2 Shaping the Future of the Economy, Transport and Environment Services (ETE) Cllr Melson reported on the difficulties faced by HCC to save £100m from revenue services expenses due to the continued squeeze on public sector spending. Delegates were invited to choose a course of action from a choice of 4 on a number of issues typical to each department in order to inform officers where parishioners' priorities were perceived to lie by their representatives. The votes were very close in each case and illustrated the diversity of community priorities in Hampshire which nevertheless need to be addressed by a reduced number of officers.
