Use: A post-emergence herbicide for use on MANAGED AMENITY TURF, including lawns, and AMENITY GRASSLAND for the control of DAISY, DANDELION, CLOVER, BUTTERCUP, RIBWORT PLANTAIN and other broad-leaved weeds.

Chemical composition: Active ingredients: Fluroxypyr-meptyl, clopyralid and florasulam.

Risks to health:

Remedy / First Aid:

Inhalation - no adverse effects anticipated during proper handling Move to fresh air, provide oxygen or artificial respiration if needed, seek medical attention if symptoms occur

Ingestion – low oral toxicity

Do not induce vomiting unless told to do so by a doctor. Wash out

mouth and continue to sip water. Seek medical attention

immediately

Skin contact – may cause sensitization by skin contact Take off contaminated clothing. Wash off skin immediately with soap and plenty of water for 15-20 minutes. Seek medical

attention if symptoms persist.

Eye contact – irritating

Hold eyes open and rinse slowly and gently for 15-20 minutes. Remove contact lenses after the first 5 minutes, then continue rinsing eyes. Seek medical attention immediately.

In all cases, remove affected person from source of contamination / exposure.

Control measures / handling advice:

PPE required when handling the concentrate – splash resistant or waterproof coverall or similar, nitrile gloves, face shield or goggles, waterproof boots

PPE required when spraying - splash resistant or waterproof coverall, nitrile gloves, waterproof boots

Keep away from food, drink and animal foodstuffs

Do not smoke, eat or drink when using this product

Wash hands before breaks and immediately after handling this product

Emergency action (fire / spillage etc.):

Spillage – Keep other people away. Eliminate all sources of ignition. Wear splash resistant or waterproof coverall or similar, nitrile gloves, faceshield or goggles, waterproof boots. Do not flush away with water. Prevent from entering soil, ditches, waterways and / or groundwater. Small spills: absorb with materials such as: clay, dirt, sand and then sweep up. Large spills: contact Dow AgroSciences for clean-up assistance. Inform Environment Agency or SEPA (0800 807060) immediately if Greenor enters drains.

Fire – Call fire service immediately (999) and show this sheet on arrival. Keep people away, isolate fire and deny unnecessary entry. Non-flammable until the water has evaporated, the residue can burn. Avoid breathing smoke or fumes which may be toxic and / or irritating. Use self-contained breathing apparatus and fire-fighting clothing. Use water fog, carbon dioxide, dry chemical or foam. Contain fire-fighting water run-off if possible as it may cause environmental damage. Remove intact containers from exposure to fire or spray unopened containers with water mist to keep cool.

Storage / transport / disposal:

Store securely in closed container in cool, dry, ventilated store when not actually in use Keep away from heat, sparks and flame
Store in original container in a dry place
Store securely in closed container in a safe place.
Store away from food, drink, animal foodstuffs or drugs
Protect from frost
Triple rinse containers
Do not cut, drill, grind, weld, or perform similar operations on or near empty containers.
