#### 2023.121 Minutes:

It was proposed, seconded, and resolved, to confirm the minutes of the Council meeting held on Tuesday 16<sup>th</sup> January 2024 as a true record

#### 2023.122 Matters Arising

#### a) Councillor Surgeries

There was no update on Councillor surgeries from the working party at this time. Cllr Adrian Robinson agreed to follow up the suggestion of combining surgeries with Councillors from Albrighton Parish Council.

#### b) Community Governance Review

It was reported that the Boundary Review Working Group had met and had included ten representatives from both Albrighton Parish Council and Donington with Boscobel Parish Council. The three representatives for Donington with Boscobel Parish Council were Cllrs David Williams, Christine Jones, and Lee Chatburn. The majority present had voted in favour of a combined Parish Council, and against incorporating Windsor Road area only. Cllrs Williams, Jones, and Chatburn had all voted against the proposal to call a combined Council 'Albrighton Parish Council', instead of 'Albrighton and Donington Parish Council'.

### 2023.123 New Business

#### a) Cosford Reported issues

Cllr David Williams reported that civilian residents at Cosford, living in Housing Association property, had started to contact the Parish Council about local issues including fly-tipping, lighting, street furniture, and vermin. There had been some success in following up these issues, notably fly-tipping.

#### b) Nature Reserve Agreement

It was requested that the Parish Clerk type out a Word copy of the original agreement of the Nature Reserve agreement to allow for an easier use of the document prior to meeting with Management Committee and Shropshire Council representatives to update it.

#### c) War Memorial Restoration Project

It was noted that the groundworks may not go ahead so the request to contribute approximately £8000 to the project by way of paying and invoice for ground works was no longer on the table. It had previously been agreed to contribute £5,000 towards the restoration project, and it was agreed to pay this sum to Albrighton Parish Council's War Memorial Fund as soon as the grant application was received by the Parish Clerk.

#### 2023.124 Correspondence: For Action

- a) Crane Quality Consulting: a request for funding for family counselling service for children and teenagers who have experienced family breakdown was considered, it was agreed not to pursue this at this time as there was no information on whether it had assisted families in the Parish.
- b) West Mercia Police a request to renew the Local Policing Community Charter was considered, and it was agreed to list the current three priorities as anti-social behaviour, drugs, and outbuilding theft. It was requested that the Police attend a future meeting.
