19/01794/ALB - Orchard Farm Ivinghoe Aston Ivinghoe Buckinghamshire LU7 9DL.

Removal of cement render surrounding timbers on two elevations at the front of the house, replacing with lime render. Undertake timber repairs if necessary. Remove acrylic paint from exposed timbers and paint with black linseed oil paint. Lime wash render to match existing render colour.

CM/0017/19 - Unit 25B Old Airfield Industrial Estate Cheddington Lane, Marsworth, Bucks, HP23 4QR. Use of the land for waste storage and treatment. Objection PROPOSED BY Cllr Bamber and SECONDED BY Cllr Lott and carried unanimously.

C/079/19 Footpaths, Bridleways, Trees and Playgrounds.

- Lower Lawn is very overgrown, the clerk will write to the landowner and request it is cut.
- Ivinghoe Aston footpath a report has been received about an overgrown footpath, there is some confusion over which footpath. Cllr Lott and Cllr Bexson will supply a map so that the resident can highlight the exact area.
- Ivinghoe Lawn trees the Clerk to contact Aylesbury Vale District Council Tree Officer and request he assists with our long-term plan.
- The bridleway is unpassable, this will be reported to Bucks County Council Rights of Way.
- The Cable Zip Wire will be located by the play area and the children's play area will be fenced for health & safety reasons.
- Ivinghoe Aston disabled access waiting for decision on funding.
- The lyinghoe football goal net has been purchased and will be installed soon.

- Brownlow Bridge Weight Restriction the farming community are unhappy about the TTRO, local HGVs are still using the bridge and these will be reported to Thames Valley Police.

- Speedwatch 70 vehicles have been 'caught' including local businesses from Leighton Buzzard.
- A Cheddington resident has requested help from Ivinghoe PC and he has been referred to Cheddington PC.
- Speedwatch signs there are 8 new signs the council would like to order. The council is waiting for LAT permission on the identified sites.
- LED Streetlights the council put the tender documents out and one company submitted quotations. It was PROPOSED BY Cllr Lott and SECONDED BY Cllr Bamber and carried unanimously to accept the quotations from Sparkx. The Chairman thanked Cllr Lott for all his hard work with the street lighting project which is greatly appreciated.
- The council supports the idea of a toad and frog warning sign and in principal agrees to pay for the full sign or if Pitstone agree Ivinghoe will share the cost of the sign with Pitstone.
