# 1. Apologies

SECONDED: Cllr I MacLeod and AGREED.

7.1 Members were taken through the photographs. It was NOTED that there were Christmas decorations on many of the graves. It was

- 7.2 Paving a quote received from Kent Grasslands to purchase and install paving around the wall memorial bench was received in the amount of £450.00. Cllr Mrs Clucas PROPOSED that the quote is accepted. SECONDED: Cllr Mrs Connell and AGREED.
- 7.3 Moles a quote for the removal of moles has been received as £60 for the first mole trapped, and then £10 per mole thereafter. It is estimated that there are between three and four moles active in the Burial Ground and two and three moles active in the Churchyard near the Burial Ground. Cllr Mrs Clucas PROPOSED that the quote is accepted and that the areas in the Churchyard are cleared at the same time, with permission from the Church Warden. SECONDED: Cllr I MacLeod and AGREED.
