Potholes.

There is a procedure for reporting potholes to Highways, who will come out and do repairs if the width and depth criteria apply. Agenda item for Annual parish Meeting.

Cllr Edmonds advised the meeting that increasing the precept to cover repairs to was not acceptable, and the matter should be raised with the County Councillor. The Chairman will contact Mrs Aston and ask her to attend a site meeting to survey the damage to the lanes. Cllr Mrs Witcher advised the meeting that Transport for bucks were on twitter.

Cllr Brown will highlight worst affected area on a map and Councillors Brown, Lewis and Mrs Witcher will meet and invite Mrs Aston.


The parish Council agreed to increase the reserve for kerbing to £4000.00
