## 80/23 Members of the Public:

No members of the public were present.

Jason Norgrove the Station Manager from Craven Arms Fire Station attended the meeting to explain the difficulties in recruiting, training, and the retention of on call Fire officers to manage the fire facilities at Craven Arms.

Jason explained that it could take up to three years to train as a qualified fire fighter who currently need to be on call for 84 hours a week and should ideally live or work near the Fire Station.

Currently Craven Arms Station is down to nine employees this being the minimum requirement and if recruitment does not take place there is an imminent danger that there would be insufficient staff to man a callout.

Jason was asking for help to advertise recruitment and members of the Council were more than happy to distribute leaflets around the Town Area.

The Chairman thanked Jason for his attendance and updating the Town Council.

#### 85/23 Highway and Amenity Items:

- a) Craven Arms Playing Fields No items to report.
- b) **Craven Arms Flooding Scheme** The Clerk reported that that the culvert by the Stokesay Hotel was regularly cleaned by Jamie Kinsey particularly during the adverse weather conditions the cost of which is reclaimed from Shropshire Council.
- c) **Highways/Street Lighting** Cllr J Fuller referred to the number of highway issue on the A49 through the centre of Craven Arms which related to faulty Highway Lights and Signs,

and damaged grass verge. Cllr D Evans and the Clerk had taken up these matters with Highway England and were awaiting a response.

Cllr S Demos raised about the streetlights that were not working along parts of Clun Road, the Clerk reported that these had been recorded on the Shropshire Council website Fixmystreet.

The Clerk to raise the issue of the pruning of trees along Corvedale Road Craven Arms

- d) Land at Corvedale Road Craven Arms The Clerk was currently obtaining an independent valuation of the land from McCartneys Craven Arms before any further progress can be made on this item, the Clerk also reported that potential for the sale of the Land should be advertised for public Consultation.
  - The Clerk reported that a request had been received from the developer, of the two houses to the rear of Barclays Bank, to use the Councils parcel of land for a period of six months to store materials and put up a site cabin during construction of the houses. The developer will pay a licence fee of £1,000 for an initial period of six-months and a returnable deposit of £1,000.
  - Subject to the Councils solicitor agreeing the Licence the Town Council agreed to the use of the land by the developer for storage of equipment and siting of site cabin for an initial period of six-months.
- e) **Benches** The Clerk will arrange for the installation of the two benches one on the play area of the recreational field and that other on the patch of land at the junction of St Johns Crescent and Greenfield Road Crayen Arms.
