- 1) To consider any apologies for absence LH was on holiday as was CCIIr BL.
- 2) To receive any declarations of interest in items on the agenda MM declared an interest in the clerk's wages.
- 3) 10 minute open forum to receive questions and comments from members of the public No public were present but the following matters had been reported to councillors:
  - There is a grate over a gulley in Church Lane where the silt is so high it's visible despite the grate being over grown with grass.TG offered to report it to Highways.
  - A resident who uses a mobility frame and frequently catches the bus has asked if anything can be done about dustbins left obstructing the pavement once emptied. JC offered to speak to the dustbin men.
  - There are potholes in Cromwell Holt which have been marked for so long that the paint is fading but they are unavoidable when there is oncoming traffic. TG offered to report them to Highways.
  - The lines on the cross roads have not been re-instated.TG offered to report this to Highways.
  - Carlton Beck is very overgrown impacting on flow. DCIIr SM offered to follow this up.

    - i) 16/01090/FUL Malt Kiln Cottage Extension There was some discussion as to whether this would impact upon privacy of neighbouring properties.

The clerk reported that there had been an email asking what was happening at the c\ivil engineering project on the Wharf. Nobody knew but a number of possible projects were mentioned including dredging and replacing telegraph poles.

The clerk also reported receiving another unreadable letter requesting a job.

FJ asked that the shoddiness of pothole repairs be put on the next agenda as works done 6 weeks ago were already crumbling with weeds growing through.

Two consultations have been received which will be agenda items for the next meeting – N&SDC Plan Review Preferred Approach and NALC Community Led Housing. The clerk reported that the Council could now declare itself able to use the Power of General Competence as she had completed and passed the CiLCA portfolio. It was agreed this may be useful for the Solar Farm payment and should be an agenda item for the next meeting.
