Hello Sandra

Thank you for your enquiry regarding an interactive map of your cemetery.

From the information that you have supplied I would estimate that the cost of providing what you are looking for would be:-

Preparation of digital cemetery map (under 1000 plots)	£500.00 One-time
Burial database incorporating MapLink for linking burial records to a digital map	£550.00 One-time
1 hour remote training	£75.00 One-time
Annual Technical support and software updates	£80.00 per annum

The above costs can be divided by a maximum of 5 years over which payment can be made without any interest charges.

Please note the following regarding the above:

Pear will produce a 1st. draft of the cemetery map in paper format for you to check and amend.

Pear will correct the digital map as per your amendments and set up the MapLink between the burial database and the cemetery map.

You will be responsible for transferring the data from your current record keeping system into the burial database - Pear may be able to assist in speeding up this task dependent upon where your burial data is stored currently.
