## KIRKLINTON PARISH COUNCIL

Minutes of a meeting of Kirklinton Parish Council held at Fir Ends School on Tuesday 15 September 2015.

#### **PRESENT**

Councillor David Shepherd (Carlisle City Council) also attended the meeting.

The Chairperson warmly welcomed David to his first meeting of Kirklinton Parish Council.

David briefly introduced himself and confirmed that he had available a small budget which could be used to assist with parish council projects.

He also outlined his proposals to hold local parish based council surgeries where demand for them was evident. Such surgeries are advertised in the Cumberland News. He would be prepared to hold a surgery for Kirklinton if required.

### **DECLARATION OF INTERESTS**

D Allan declared an interest in Agenda Item No. 7(1)(b) – Payments, Subscriptions and Receipts – and took no part in the ensuing discussion.

The Clerk reported that he had received no further information on the above highways issues. Councillor John Mallinson had advised the Clerk that he was on holiday and would follow up the issues on his return.

#### **AUDIT FOR THE YEAR ENDED 31 MARCH 2015**

The Clerk reported that the audit undertaken by the exernal Auditors, BDO Stoy Hayward, has been completed and that no matters of concern had been identified which required the issuing of a separate additional issues arising report. The Annual Return was therefore approved and accepted by the Parish Council. A 'Notice of Conclusion of Audit' would be displayed on the public notice board for a period of 14 days.

#### PLANNING APPLICATIONS

### (a) Application No: 15/0352 (John Braisted)

Erection of 1no. dwelling (Outline) on land between Stonelea and Bluebell Cottage, Smithfield, Carlisle.

The decision of the Planning Authority to refuse permission was noted.

#### DIVERSION OF PUBLIC FOOTPATH AT FIR ENDS SCHOOL

The Parish Council supported the proposals to divert the footpath and amend the Definitive Map accordingly.

#### **GAMBLING ACT 2005 – DRAFT STATEMENT OF GAMBLING POLICY 2016**

The draft Policy was noted without comment.

### TRANSPARANCY CODE FOR SMALLER AUTHORITIES

The Clerk reported that Kirklinton Parish was one of thirteen parishes that had taken up CALCs offer to host the relevant documents in order to meet the above Code. All the required documents were now available on CALC's website.

The Clerk reported that the Government had made available some funds to assist smaller Parish Councils to publish information electronically on their own dedicated website. The

Parish Council was not convinced that expenditure in excess of £200 could be justified at this point in time and agreed that an application for funds from the Transparency Fund should not be pursued.

### **WORKPLACE PENSIONS**

The Clerk reported that the Pension Regulator had confirmed that if there are no members of staff that need to be automatically enrolled, there is no requirement to have a pension scheme in place on the staging date. Consequently, until such time as a future Clerk requests to be included in a workplace pension scheme no further action is required other than to report back to the Pension Regulator at the appropriate time.

#### REQUEST FOR A SPEED RESTRICTION ON THE ROAD AT ALSTONBY

The Clerk reported that he had received a request from the residents of properties at Alstonby for the Parish Council to ask the Highways Authority to impose a speed restriction on the stretch of road from Alstonby Hall to Alstonby Grange.

It was agreed that the Clerk should obtain some additional information.

This prompted a wider discussion on speeding around Smithfield village, during which David Shepherd offered some advice on 'self policing' the problem based on the voluntary scheme set up in Brampton. He also indicated that he would be willing to help set up a similar scheme in Smithfield if the Parish Council wished to pursue the issue further. It was agreed to give the matter further consideration at a future date.
