5.0 CHAIR'S REPORT

6.0 APPLICATIONS and DECISIONS - The following applications were considered:

Ref: 25/01124

Location: 13 Hazling Dane Shepherdswell CT15 7LS

Proposal: Erection of a detached dwelling, vehicle access and associated parking (Self Build)

Cllr Denyer proposed that Council objects to this application on the grounds of non compliance with Tree Preservation Orders (TPOs); the removal of protected trees necessitates their re-establishment, leaving no viable

space for development. The proposal constitutes overdevelopment of the site and raises significant concerns regarding access. Seconded by Cllr Hunt, **all AGREED**.

Location: Long Lane Stables Long Lane Shepherdswell CT15 7LX

Proposal: Erection of a stable, store, office building, with domestic kennel, diesel and water tank. Erection of a storage building and siting of a mobile home for workers accommodation (retrospective)

Cllr Roberts proposed that council state that they have considered this application and have no comment to make, seconded by Cllr Denyer. **All AGREED**.

Location: 53A Westcourt Lane Shepherdswell Dover CT15 7PU

Proposal: Pollard to a finished height of 9 metres of one Sweet Chestnut the subject of Tree Preservation No 17 of 2009. Due to recent heavy winds and the weight (bearing chestnuts) two lower limbs have snapped out, leaving the tree out of balance with a quarter of the canopy missing and causing concern. Recommend: Pollard the tree to a finishing height of 9 metres approximately.

Location: Westcourt Place 77 Westcourt Lane Shepherdswell CT15 7PU

Proposal: Crown reduce by approximately 4-5 metres in height and 2-3 metres in lateral spread of one Hornbeam (T1) the subject of Tree Preservation Order No 15 of 2008.

Ref: 25/01162

Location: Whitehall Inn Cottage 21 Eythorne Road Shepherdswell CT15 7PB

Proposal: Prune back to trunk selected lateral branches overhanging garage roof of one Sycamore the subject of Tree Preservation Order No 4 of 1990.

Cllr Roberts proposed that all 3 applications above are referred to the Tree Officer for their comment, seconded by Cllr Hunt. **All AGREED**.
