#### Fire Hydrants

Steve Lewis Resilience Manager, Operational Planning from KFRS gave a very informative presentation at the October meeting regarding fire hydrants. He said the public do not recognise the importance of hydrants as an asset and they need to be looked after. In Kent there are 29,500 hydrants, of which only around 5% are used each year. However, if one is needed, it is vital that it is in good working order. Steve detailed the main issues with hydrants, which can be viewed on the following website:

This website also gives details of how to report a problem, if you notice one when out and about. KFRS like to work with communities, and have a database of large water reserves including farms, ponds, lakes and swimming pools so that they can use those if needed. They are fully insured to replace and repair after an emergency.

## News from the Parish during the Autumn

A sofa was fly tipped on the recreation ground and then set on fire on Sweetbriar Lane during September. If you have any information please contact Julliette West or Crime Stoppers using the numbers below.

A "Den" was discovered on the old DDC owned allotment site off Cherry Grove in October. This is a very concerning issue with evidence of substance misuse and fire lighting as well as trespass and fly tipping. The local Police team, DDC's Community Services Unit, Environmental Health Department and Kent Fire and Rescue have all been involved in dealing with this situation.
