What you need to do now - Accepting our offer

You are also agreeing that you will provide further information about how you spent your award and the outcomes of the award if requested by Groundwork, Tesco or any of our partners. To agree to this condition, you are required to complete this process through a secure web portal for Groundwork UK's Programme Management System 'GIFTS.'

Acceptance of the grant needs to be completed, if you have any outstanding information that is due to be returned to us you will find this detailed below as part of the special conditions of your grant.

Special Conditions:

Before you completed your Bags of Help application, you would have needed to create login details with your email address and a password. If you have forgotten your password, please click on 'Forgot Password' and you will be able to create a new password. As soon as you have done this, you will have access to the relevant forms that need completing by clicking on the grey tab titled "Requirement Form". Here, you will be prompted to provide some additional information and complete the acceptance form and other information to accept the grant offer. Please follow the instructions on the screen. Once you have submitted the forms, you will receive a confirmation email.

You should add the address mail@grantapplication.com to your email account to ensure that you receive future requests and information regarding your award. Please note, if you need to contact us, you should email tescobagsofhelp@groundwork.org.uk

In the 'Requirement Form' section online you will need to complete and submit the following information:

- Accepting the award offer and agreeing to the conditions of this letter.
- Bank Details Information
- Bank Signatories Details

You must complete and submit all forms by **Monday 12th April 2021** or your grant offer may lapse. Please contact us if you need further time to complete the process. Please note, once you have submitted your documents, it may take us up to 20 working days to check your information. We will email you to confirm once your payment has been processed.

By accepting our offer, you accept the terms on which we offer the award, and you enter into a legally enforceable contract with us. You also acknowledge that you have carefully considered this letter and its terms of award and that you fully understand and accept them.

Once you have completed and submitted the forms to our satisfaction, we will pay 100% of your award by BACS. Please be aware that **no payment will be released until we receive the above information from you correctly completed** where appropriate. Please note you have **12 months to spend your award from the date of this offer letter**.

Accountable Body/Fundholder

Please see guidance below if you would like us to pay your grant to an Accountable Body instead of paying your group directly.

What does an accountable body do?

An accountable body generally takes responsibility for the legal and financial management of a grant given to a particular project. The accountable body will receive the funding programme, will hold and administer grant funds on behalf of an unincorporated community group or if a group does not have its own bank account, and are **legally responsible** for the proper use and management of those funds.

What is required from an accountable body?

- The accountable body must be solvent and have proven competence and experience in administration and financial management.
- It must be a legal entity
- Must have effective systems of management to deliver projects.
- Be able to monitor project performance.
- Must be incorporated

Who can act as an accountable body?

Any legal entity that meets the above requirements.

For example, these may be:

- Local Authorities
- Parish & Town Councils
- Registered Charities
- CICs
- CIOs

Who cannot act as an accountable body?

An accountable body shouldn't be:

- A Business **not** registered with Companies House

- An **unregistered** charity or community group
- An individual

VAT Status

This payment to you from Groundwork UK is an award. If your organisation is unable to recover VAT, the award is inclusive of VAT incurred on eligible expenditure.

You should seek specialist advice on whether your organisation receiving this award incurs any VAT liability as a result of any goods or services you are supplying to third parties as part of the Bags of Help scheme.


When do you need to get in touch with us?
