  - Cllr R Conway would discuss with the owner of the land adjacent to the playing fields about the provision of an appropriate kissing Gate to help prevent the escape of cattle onto the playing fields and allow pedestrian access between both parcels of land.
- b) Defibrillators The lease of the defibrillator to be sited at Craven Arms Discovery Centre was agreed in principle subject to appropriate siting. Cllr S Demos was to contact Harry Tuffins concerning the provision and siting of a defibrillator at Harry Tuffins and it was reported that HALO will be providing a defibrillator at the Craven Arms Community Centre.
- c) Christmas Lights Cllr S Demos would make a report to the next meeting of the Council concerning arrangements for the Christmas Trees and Lights this year. The Clerk would apply for a highway licence for the Christmas Lights which cross the highway in Market Street Craven Arms.
