

The meeting of Egerton Parish Council was held on Tuesday 4 July 2023 7.30pm Committee Room, Millennium Hall, Egerton

2) Declarations of Interest

3) Minutes of the Previous Meeting – 6th June 2023

The minutes were approved and signed as a true record of proceedings.

4) Matters Arising from 6th June (not covered by the agenda below)

a) The George Pub. Chair John Lawton confirmed a Working Group had been established. Richard King will chair the group; EPC chair John Lawton and Cllr Simon Palmer will be members of the group.

b) School bus to Homewood in Tenterden

KCC will not support a school bus from Egerton to Homewood for the 2023-2024 year on the basis that it was not budgeted for. It will start up again for the 2024/25 school year. There has been a backlash against this decision and multi-parish and borough Cllrs have formed a working group to find a way forward with ABC. Two school buses from Ashford to Tenterden have also been axed. County Cllr Charlie Simkins has been contacted, and asked to apply additional pressure on KCC to find the funds to run the school services needed.

Action: Chair John Lawton to draft a letter to County Cllr Charlie Simkins to express concern about the unacceptable one-year gap in the school bus service.

c) Emergency Plan

Cllr Pat Parr is in charge of updating the plan; Cllr Claire Foinette is assisting. An article will go into the next edition of Egerton Update to try and identify people to go onto the list and bring forward volunteers with the equipment that will be needed in an emergency such as $4 \times 4 s$, tractors and electricity generators. A new telephone tree is needed, and volunteers are being asked to join it.

Action: Chair John Lawton to add the article to the home page of the website.

d) Renewal of fencing around the cricket field.

Vice Chair Peter Rawlinson advised that following a meeting with the Chair of Egerton Sports and Playing Fields Committee, EPC has committed to contributing towards new fencing but will not fund additional costs of rabbit protection measures. An updated estimate on potential costs will be circulated ahead of the next meeting.

6) Footpaths Report 159 (See Appendix i)

Cllr Pat Parr advised that KCC has stated that it does not have the funds to deal with a record volume of issues and that three issues have remained live on the repair list for Egerton since September 2021. KCC priority is to repair those that represent a danger to life.

A tree has fallen across and blocked the footpath running from Link Hill Lane.

Action: Clerk to write a letter to the landowner to ask for the tree to be removed.

Report no. 159 of the Egerton footpaths representative for July 2023

- 6 Outstanding Items remain from the April 2023 report. * Asked KCC why no response

- 2 New Items

The outstanding issues below are listed with the KCC Reference, the date reported, the footpath number, the location, the difficulty experienced and the status of action.

- 1. **PROW 210959063.** 10/09/21. AW75 at Heronsdale, Wanden Lane. Egerton resident complaint of overgrowth (brambles) and fence panel leaning towards the footpath. Status: Still Awaiting Allocation.
- 2. **PROW211126930.** 09/11/21. Part of AW87 to the west of the church behind the Glebeland houses where the path is quite narrow. Badgers have again been active and collapsed the side of the path about halfway along. Status: Still Work Scheduled but it is accessible with matting in place until a more permanent solution is found. Status: Still in Progress.
- 3. **PROW211117086.** 21/11/21. AW64 Footpath opposite Egerton House on Greensand Way in a small, wooded area towards the byway up to Coach Road. Two planks missing/broken on the bridge over a small stream. Status: Still Work Added to Forward Maintenance Plan.
- 4. **PROW220641396.** 22/06/22. AW81. Stone Hill to Green Hill. At the Parish Assembly two separate reports were made regarding the boundary stile between the Stone Hill properties to the large field out to Green Hill. The stile there is too high for ladies to manage. Status: Still Awaiting Allocation.
- 5. **PROW230285561.** 07/02/23. AW67. Egerton House Road, next to Willowdene, the 'finger' of the fingerpost at the entrance to this footpath has fallen off the post. Status: Still Allocated Awaiting Inspection.
- 6. **PROW230288567.** 07/02/23. AW97. Near Frasers on Barhams Mill Road the fingerpost is leaning into, and being held up by, the hedge. Still Allocated Awaiting Inspection.



NEW ISSUES:

1. **AW95 at Coldharbour Farm Complex**. 20/06/23. Report from a resident. Broken gate and vegetation clearance required on this footpath near Frasers (see photo). Contacted Lisa Fraser

about the gate. She advised they had fixed the gate and cleared the nettles! I thanked them. **Item Closed.**

2. **PROW230657059.** 26/06/23. AW91. Up Link Hill Lane on the corner between Bedewell and Wellacre Barn and before the steps leading up to the fields there is a fallen tree. Can just about get past but needs to be removed.
