Planning

At the next parish council meeting on June 12th, we shall consider new applications:

'Land east of Station Road – erection of stable block and menage with new access' (18/01658/APP); and

'Manor Farm, Station Road – deconstruction of section of stone boundary wall and rebuilding with reinforced spine' (18/01727/ALB).

· Council had no objection in May to applications:

18/01362/APP for **20 Millfield Avenue** for a 'front and rear extension with pitched roof to replace existing flat roofs'; and

18/01136/APP for **Barnwell Farm, Station Road** for 'demolition of existing flexible use building and erection of replacement flexible use building'; and

18/01382/APP for **New House, Tompkins Lane** for 'part two-storey extension and first floor build over garage'.

• AVDC has approved **New House, Tompkins Lane** – single storey rear extension (18/00842/ACL).

Licensing

At our meeting on May 8th the application for a premises licence for Manor Farm was on the agenda and over 30 people attended the meeting. After the applicants explained their reasons for the application, residents expressed their concerns. Council agreed to make a representation to the AVDC Licensing Sub-Committee, which will consider the application on June 6th.

Vandalism to Signs

Three sign posts were vandalised on the night of May 19th – two bus stops and one for the Village Hall. We now await Bucks County Council replacing them.

New Post Office

The new post office at The Plough was officially opened on Friday 25th, by The Speaker, the Rt Hon John Bercow, MP for Buckingham. Adrian Lambourne represented the parish council and several children from Marsh School were present. Stella has lots of photos and there was an item on local ITV news.

Annual Parish Meeting

The open meeting for all parishioners was on May 22nd, attended by four residents, ClIr Angela Macpherson and Chris Anstey, who presented a report on the activities of the three local charities. Minutes, the Chairman's and Angela's reports on the past year are also available on the MGPC website.

Speeding

We are resuming sessions with the Sentinel camera. We have the camera for the first two weeks in June and have some vacant slots if anyone would like to help – each session takes an hour (the first one is observing an experienced operator).

We are also expecting a quotation for a Castle Street speed survey from Transport for Bucks, in time for our meeting on June 12th.
