PUBLIC CONSULTATIONS – 9 February to 23 March

Highways England (HE) is now entering into the next phase of planning, the Pre-Development Consent Order. HE is required by law to consult the local community about its proposals for the Road Scheme. This is **your** opportunity to get involved. [See page 2 for list of venues] Response forms will be available for the public to record their comments. These can be completed at any of the events and left with the project team or sent back separately via Freepost address or submitted online. **Deadline for responses is 23.59 on Friday 6 April 2018.**

You may well feel that with the northern bypass chosen as the preferred route, our job is over. Far from it...read on!

There are still many key issues of concern where we, as a local community, can still play an important role in influencing planning decisions. By attending these Public Consultations, each and everyone one of us can actively give feedback, which will be recorded and considered by HE in further developing their proposals. If we fail to influence the road scheme (tunnel, general layout, and junctions) from a local perspective, it could adversely affect our community for years to come.

Some key issues and questions to highlight

Road Management: It is essential that any road management schemes put in place by HE, before and throughout the construction, do not significantly impact the local road infrastructure. For instance, we might see an increase in the volume of vehicles (especially HGVs), additional rat running through our villages and difficulty in accessing roads and amenities. Excess usage of our B roads could require frequent repairs.

Construction on Site: Ultimately, the construction phase (5-6 years), estimated to start in 2021, will have the most impact on the everyday lives of the local community. How will the inevitable noise and light pollution affect us? Which roads are earmarked for closure or alteration leading to longer travel

times or gridlocks? How will the location of their vast workforce, equipment and vehicles affect the community and the environment?

The Environment: Will the river Till be contaminated during the building of the viaduct and how might this affect the local habitat? Will the runoff from the tunnel excavation filter through to the whole river system? How will the spoil from the tunnel be dealt with and could this affect the environment?

<u>Landscaping</u>: The need to protect our countryside, by ensuring that landscaping is an integral part of constructing this *expressway*, should be paramount. Limiting the height of the viaduct to shield the community from unnecessary noise and visual impact is hugely important.

<u>Farm vehicle access</u>: Farm vehicles and their machinery need easy access to their land, while ensuring they are not re-routed through villages.

Legacy for our community: HE is to be held accountable for providing a positive legacy for future generations to enjoy.
