

# Neighbourhood Plan questionnaire results

Some basic information. The graphs below comprise the graphical results from the questionnaire conducted in 2016.

- A total of 672 questionnaires were delivered.
- Every adult resident and everyone on the electoral roll received a personal copy. Non permanent resident dwellings / second homes received one questionnaire per household.
- 254 (38%) of the questionnaires were returned comprising:
  - 76 persons identifiable as being on the electoral roll [this figure is probably misleading as not every person could be identified from the returns].
  - 164 full time residents
  - 90 'second home' owners (non full-time residents)
- Not all persons answered every question
- There were many written comments which have been analysed and digitally recorded.

Interpreting the results.

At the end of the title, figures in square brackets '[-]' were the number of responses received.

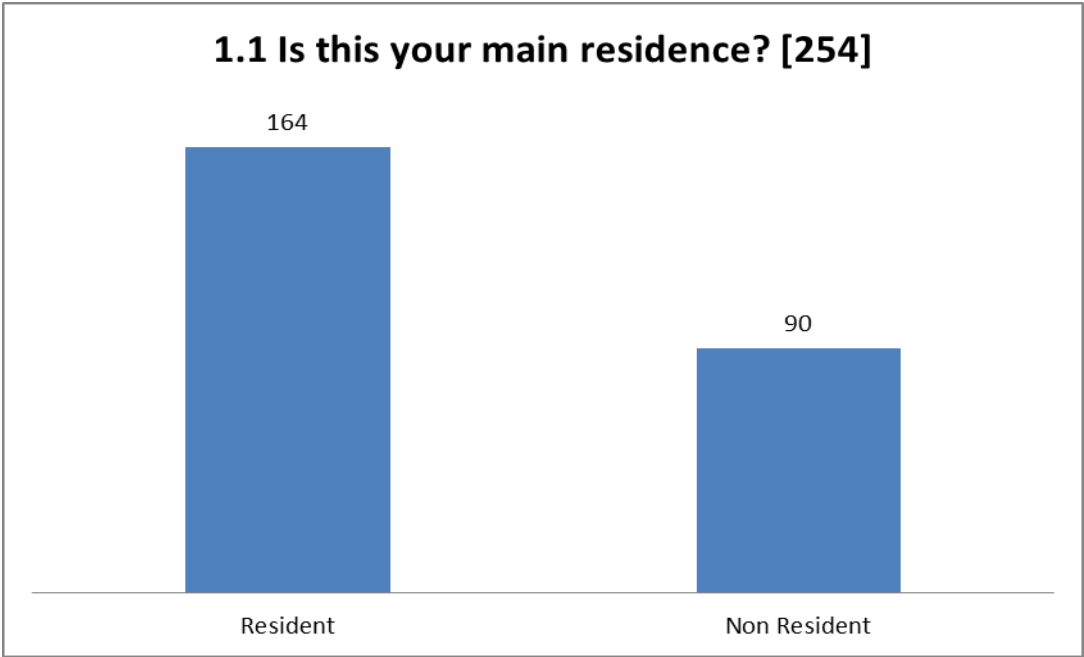
Where a question provides a range e.g. 'strongly agree' to 'strongly disagree' the numbers in the square brackets '[-]' are those responses (numbers or percentages) either side of the central 'neutral' number. Where a number [in brackets] is provided for the central 'neutral' score this number is a percentage of the total.

The data in Section 1 'Households' is not precise as there is duplication of answers depending on the number of persons per household; however although not strictly accurate, the data does demonstrate the general trends.

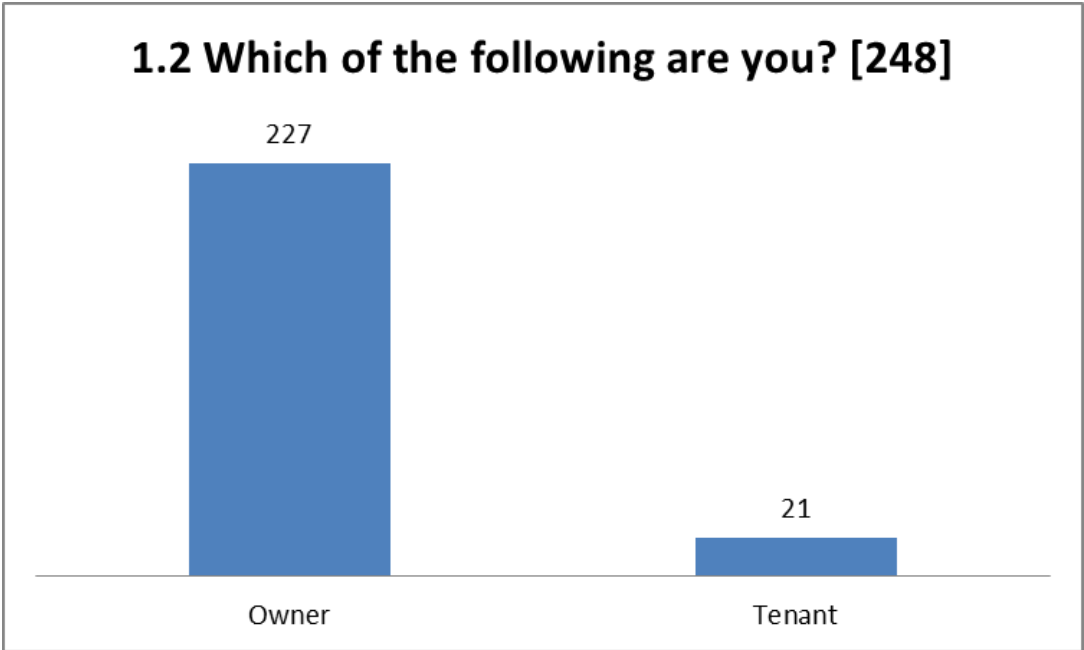

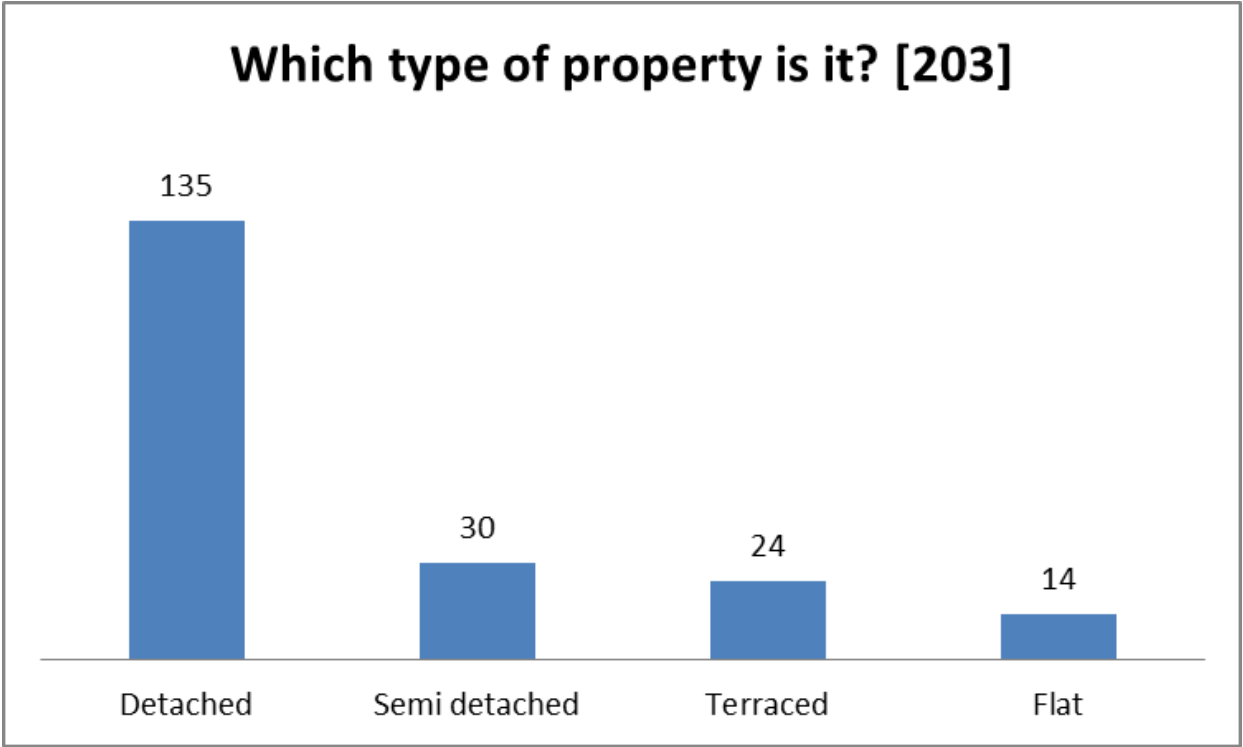

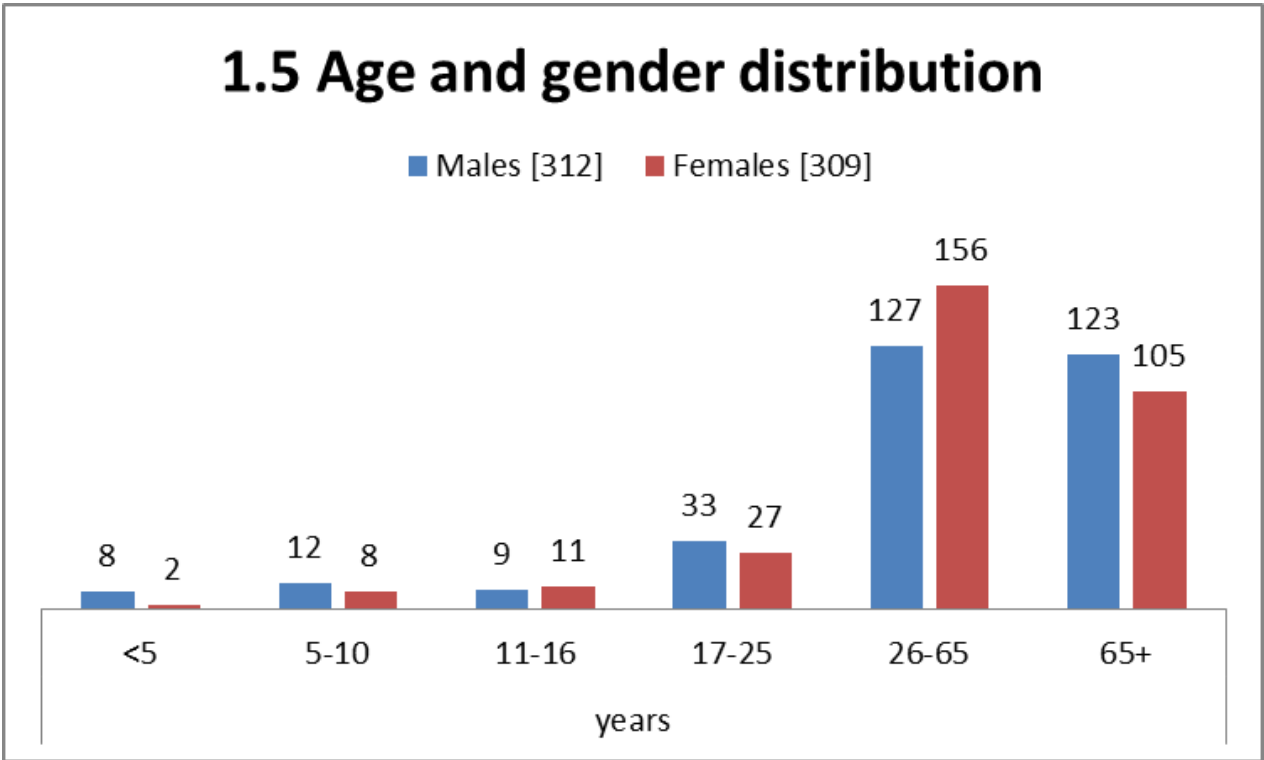

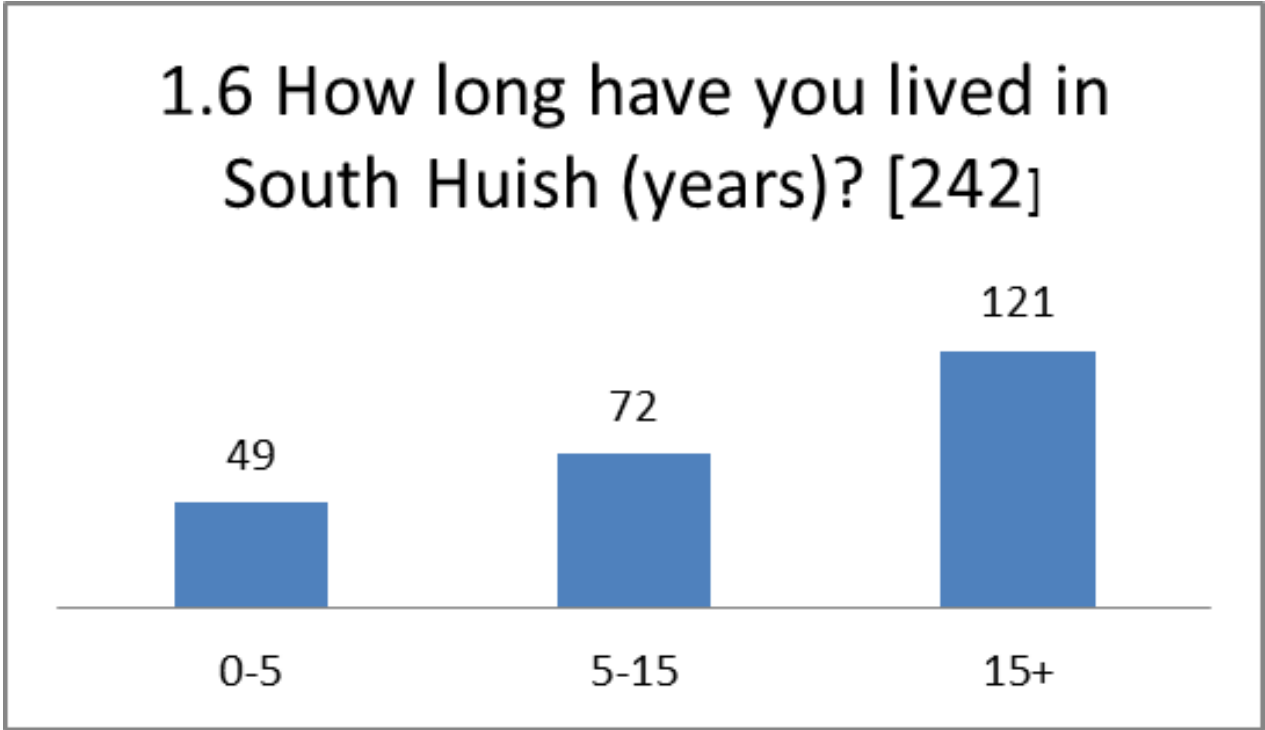

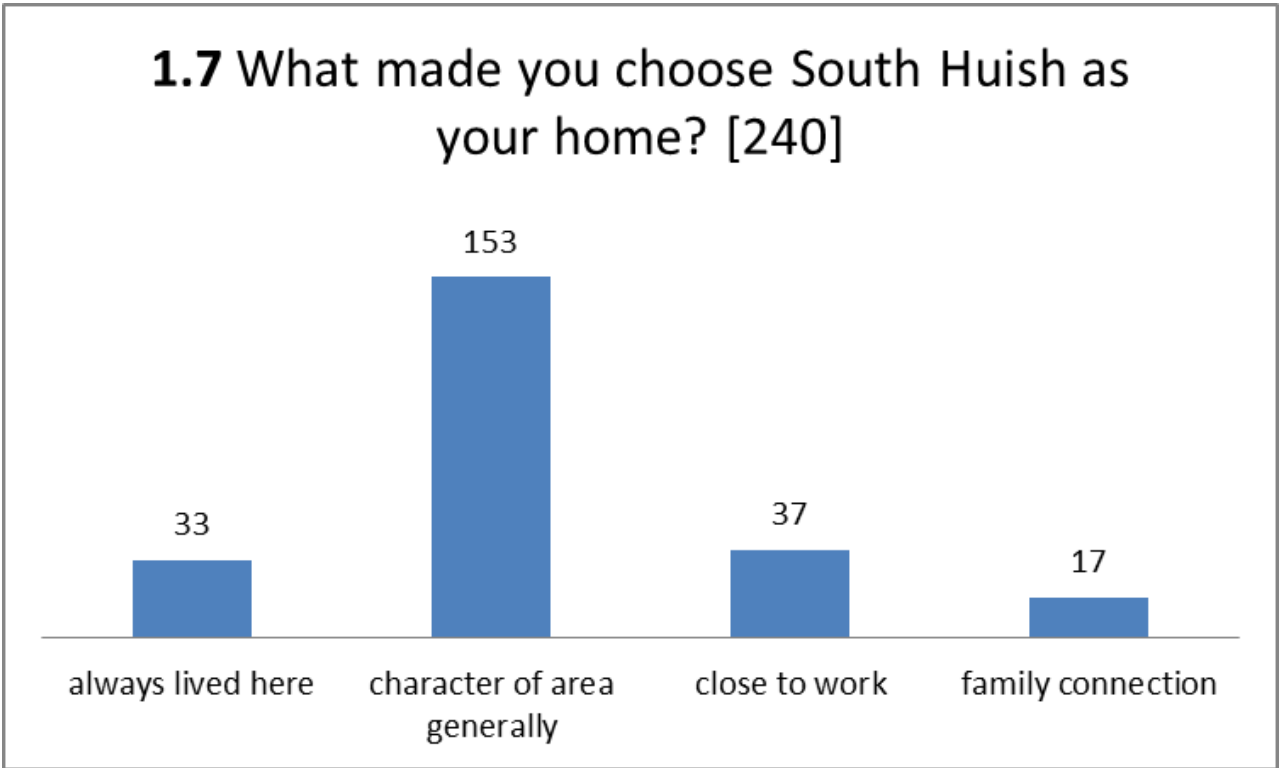

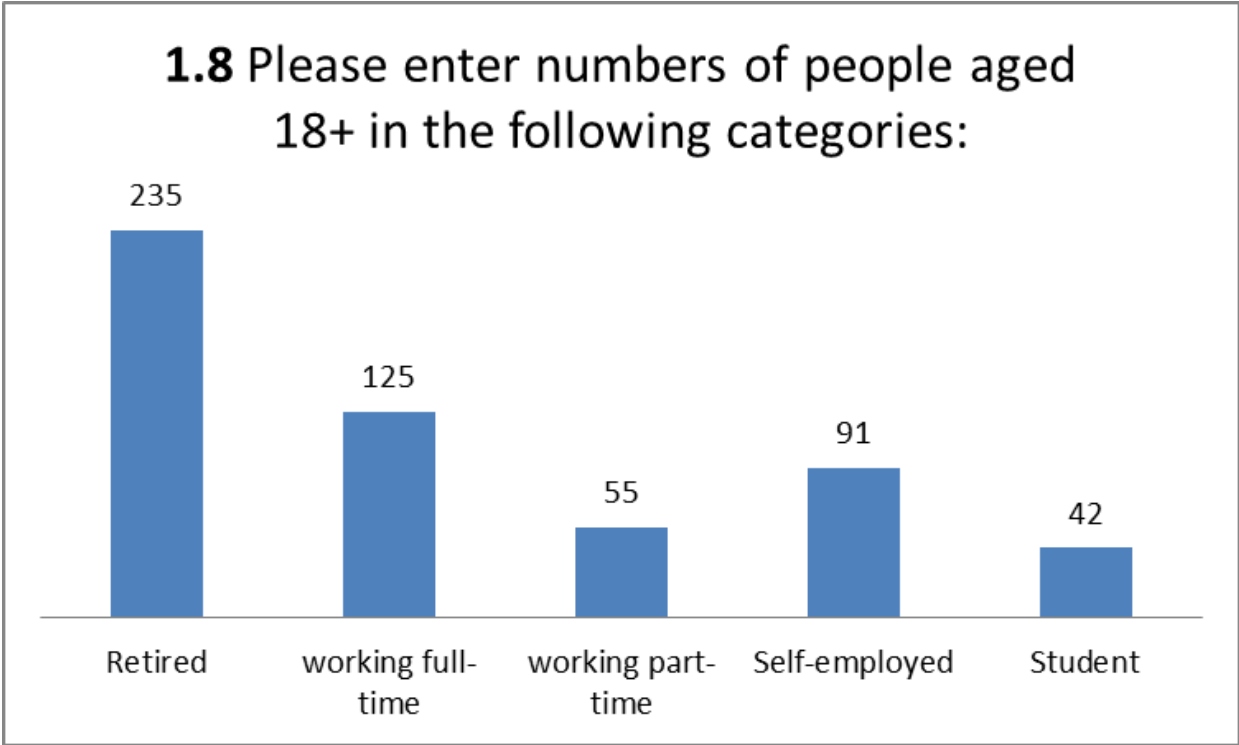


## 1.7 What made you choose South Huish as your home?

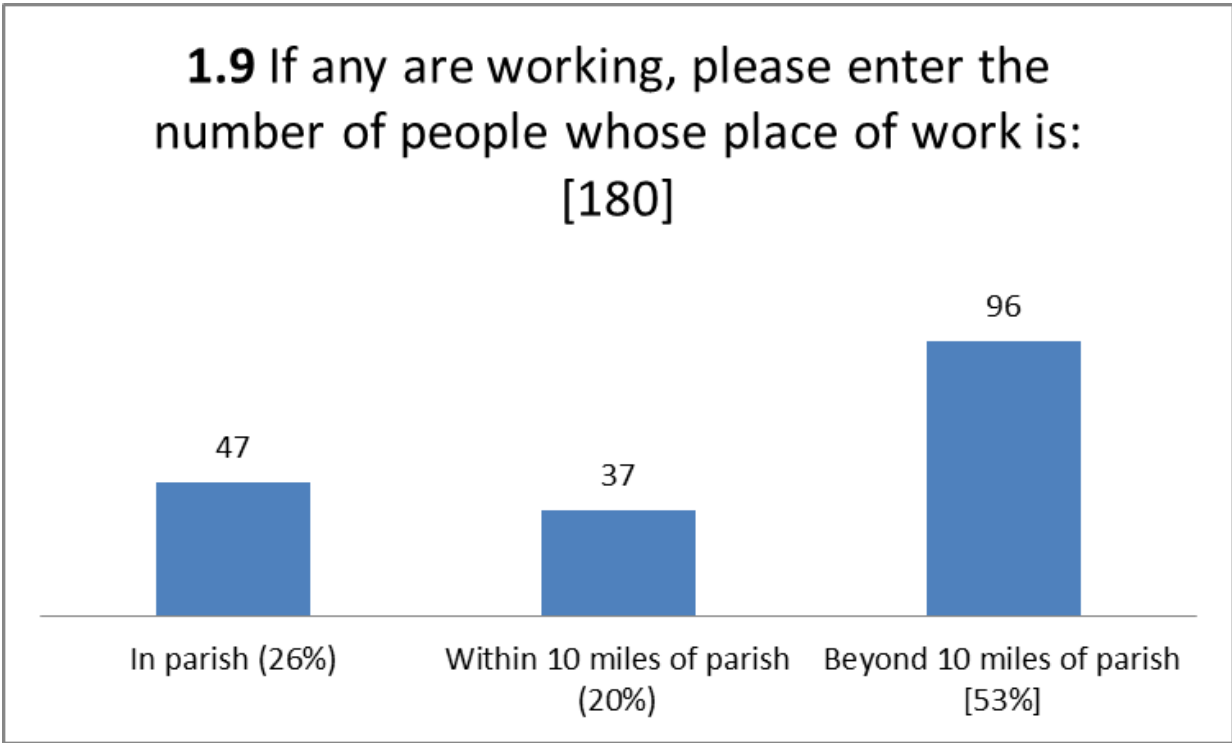

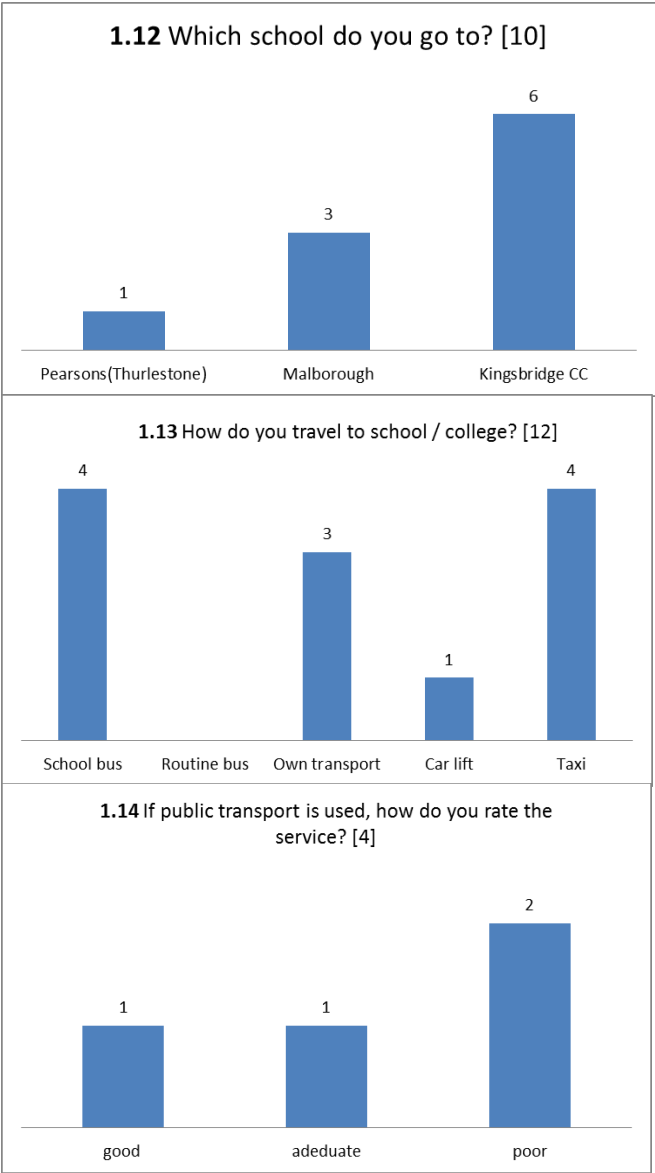

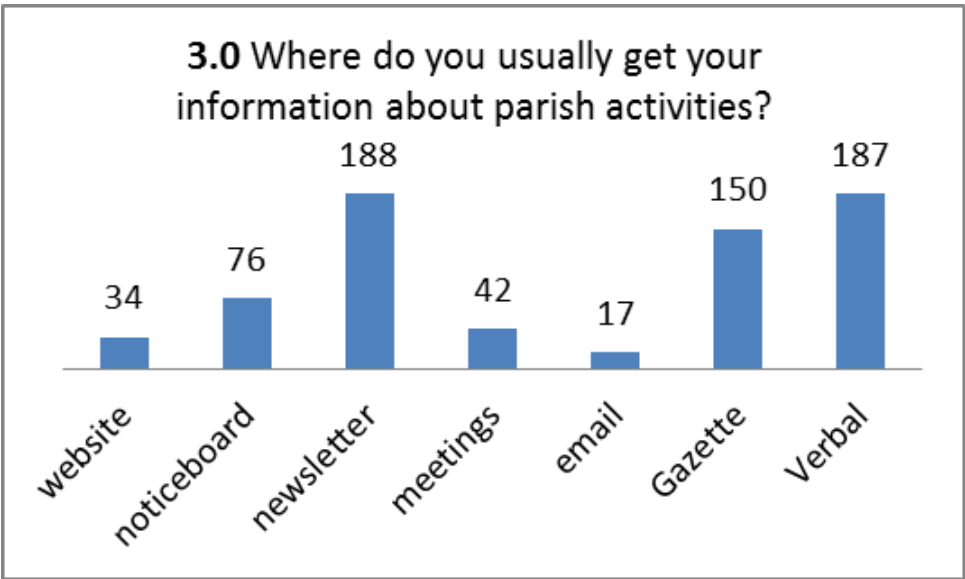

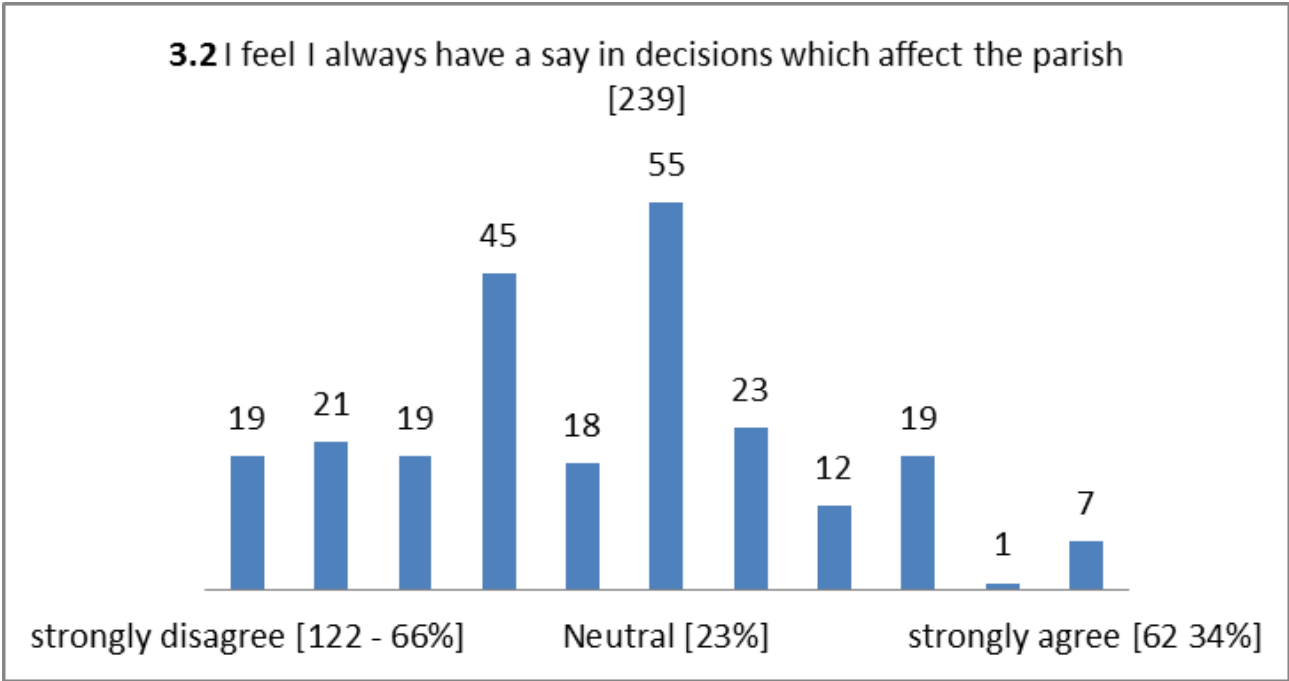

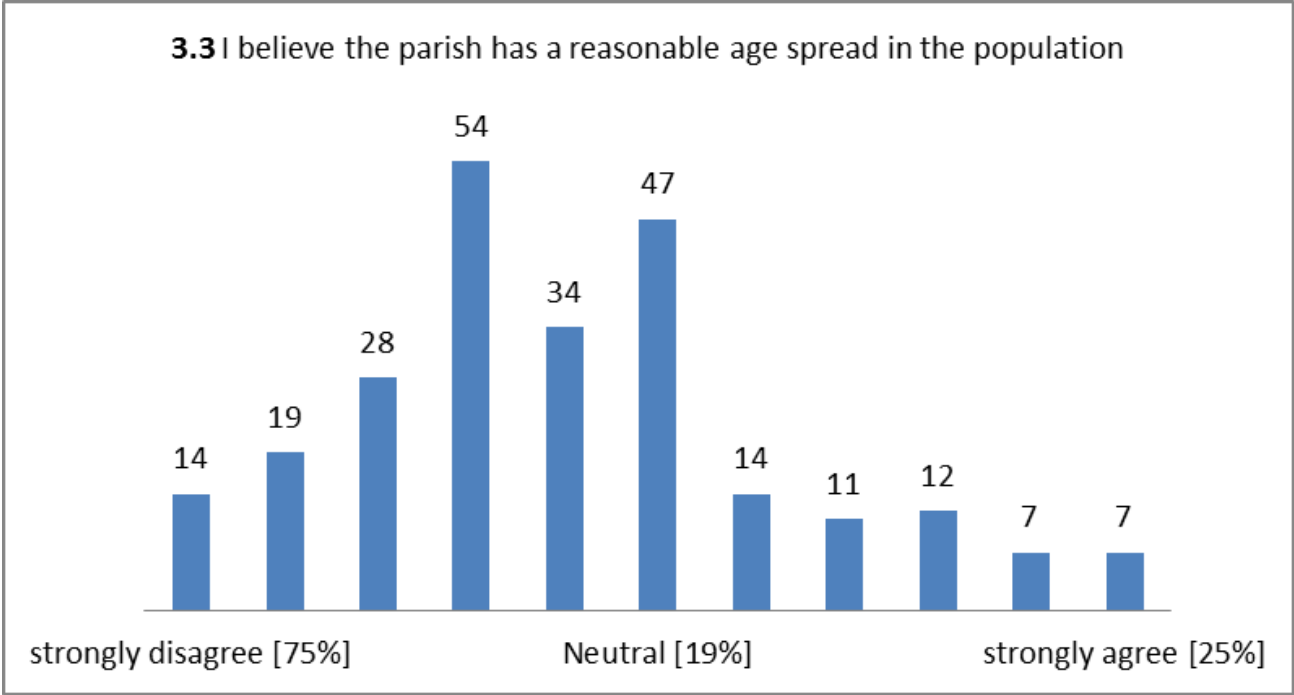

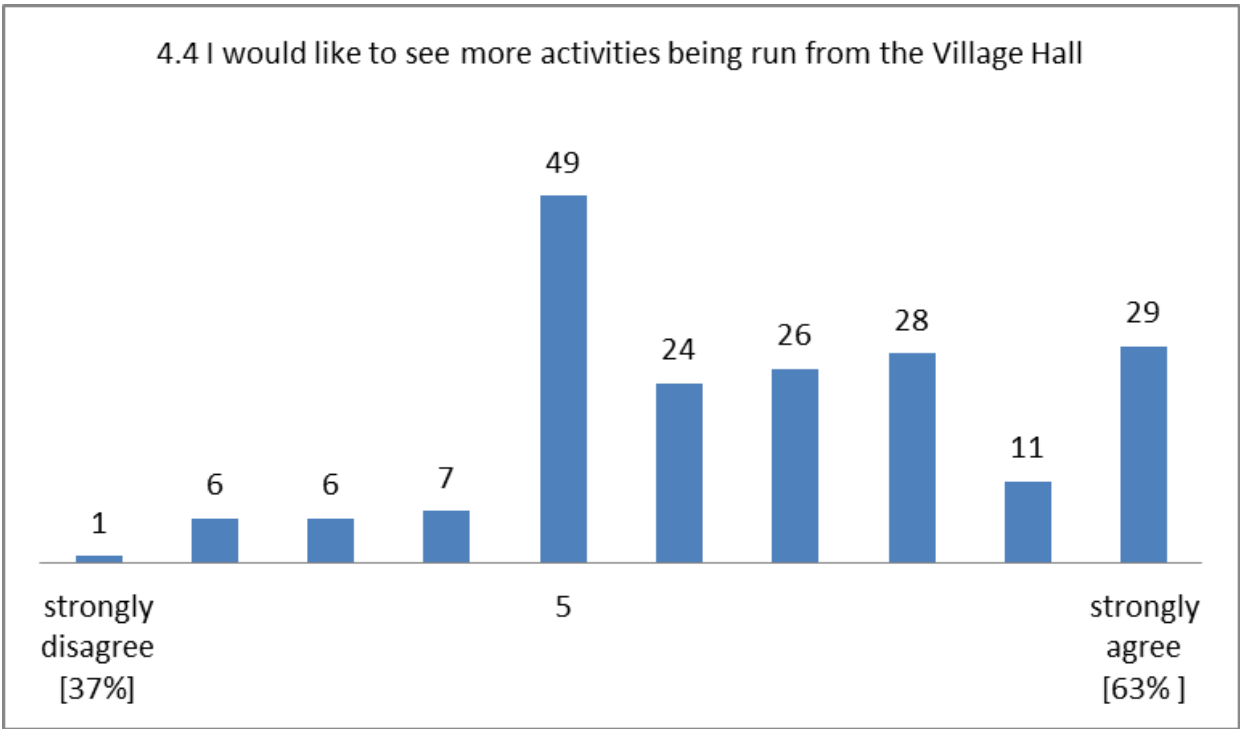

4.3 How valuable do you rate our amenities? 2<sup>nd</sup> graph ranked lowest to highest



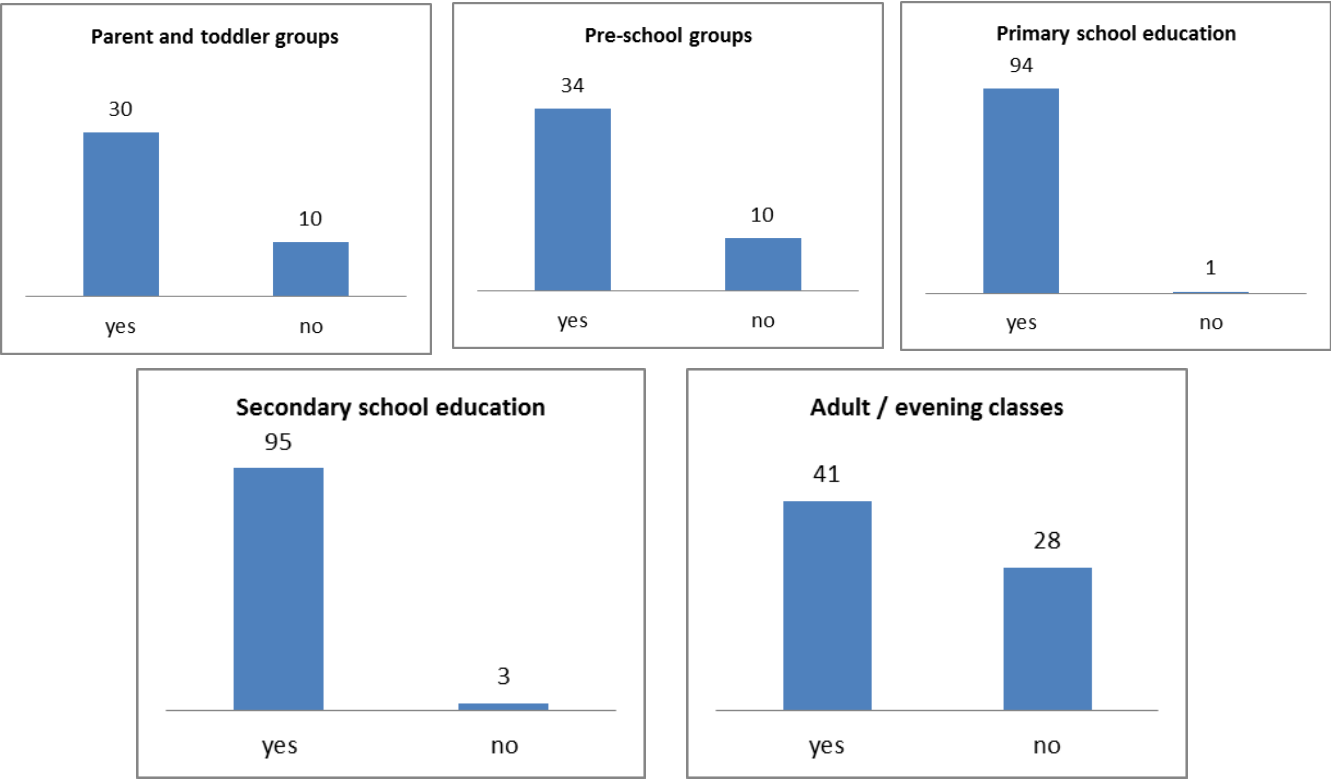

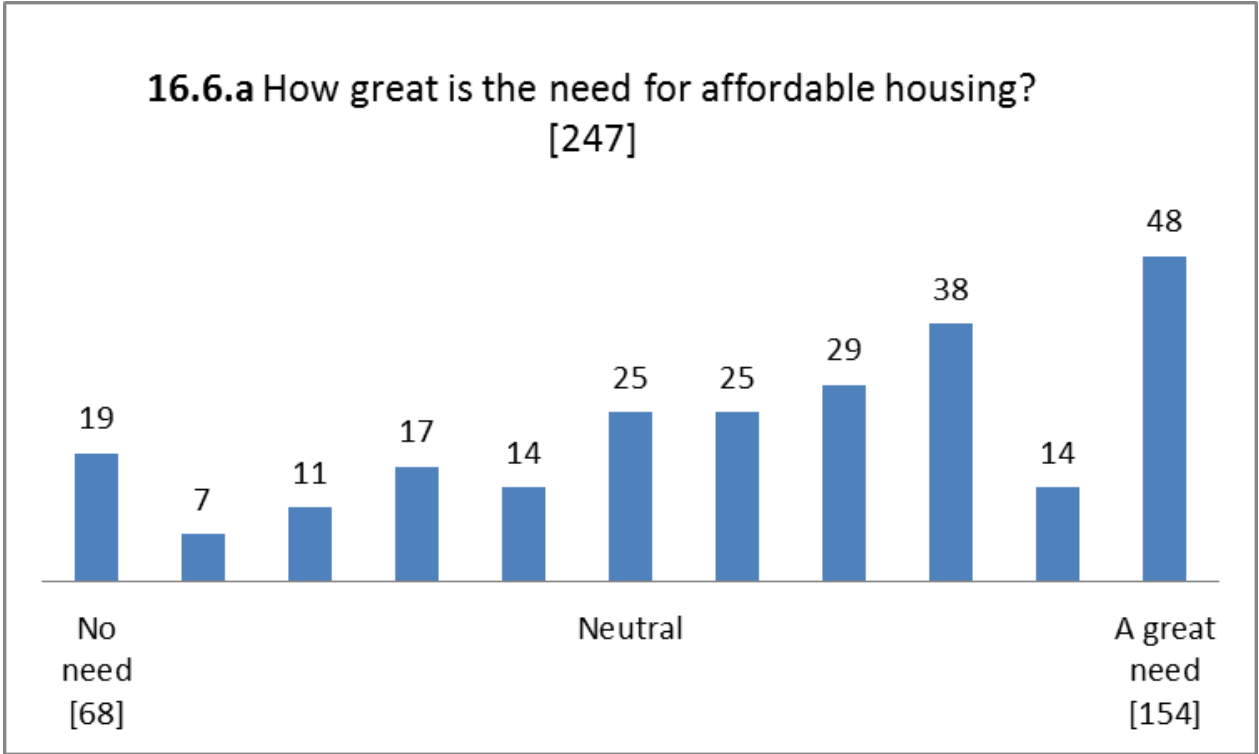

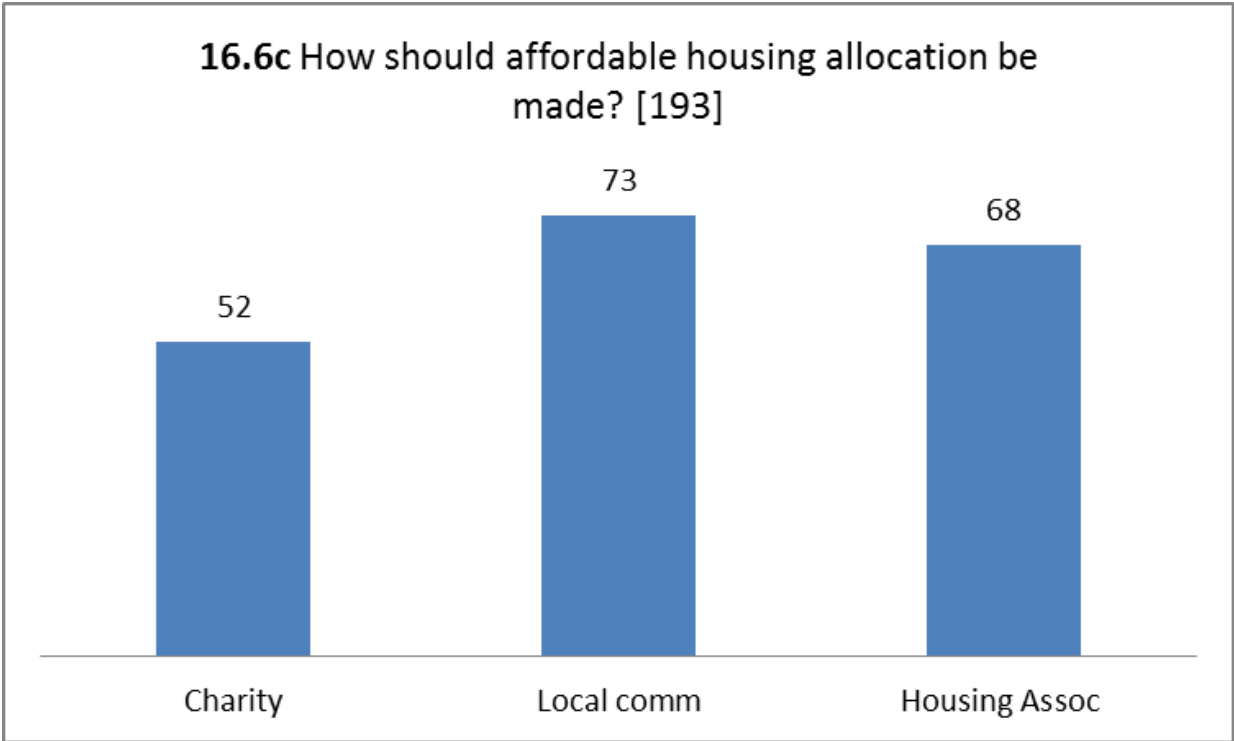

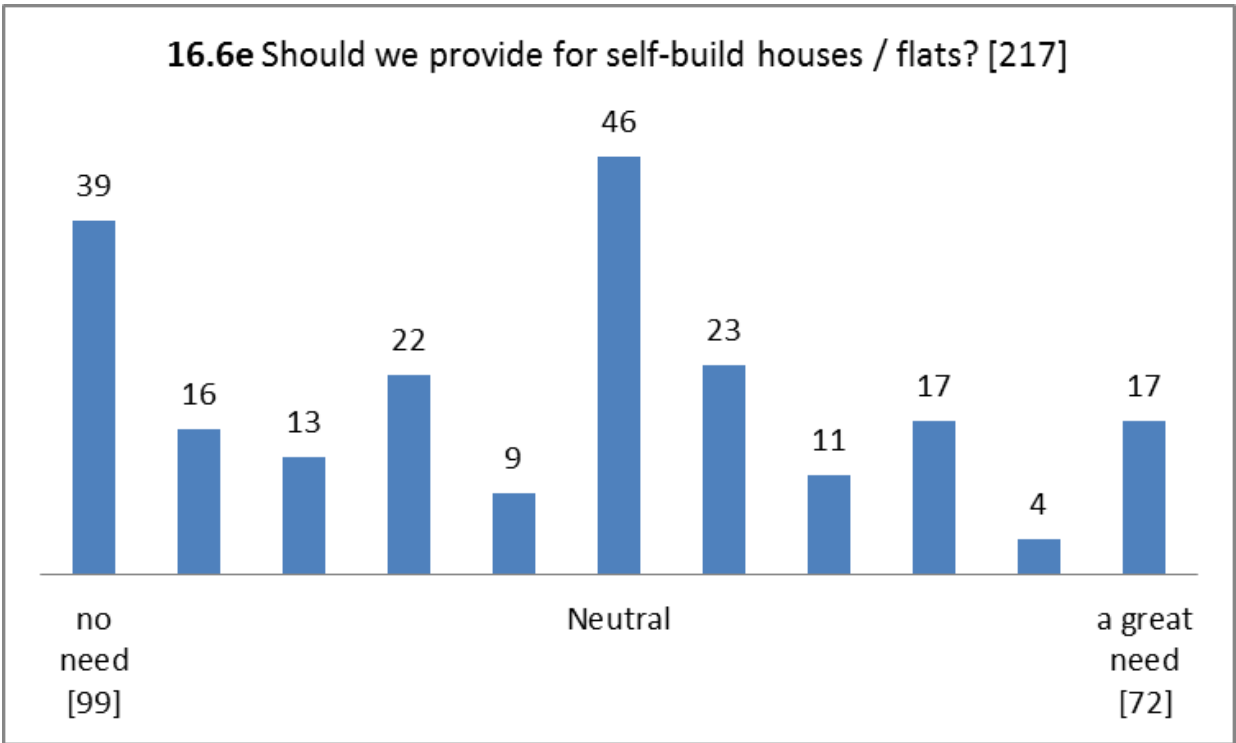

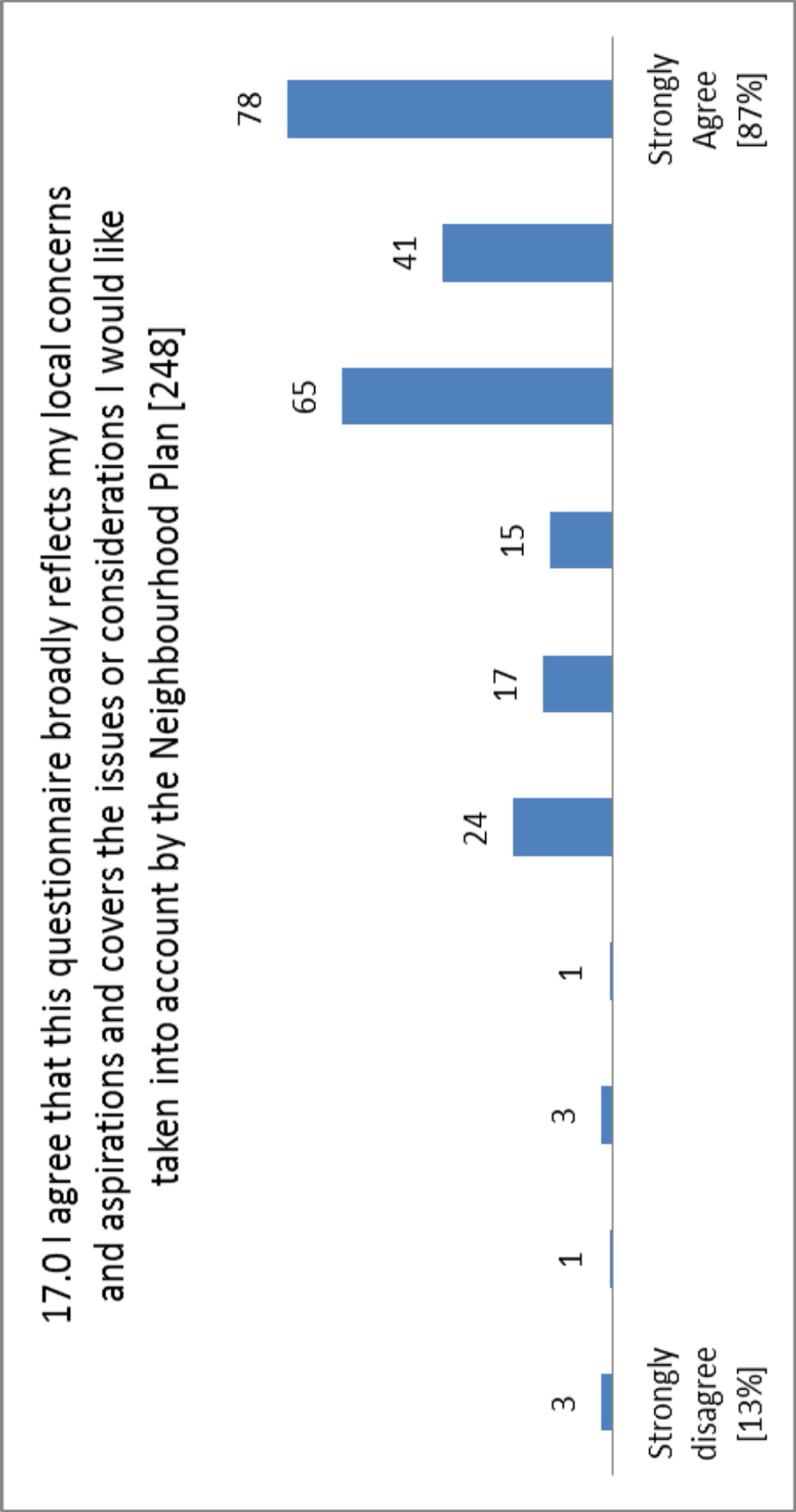
