The Parish Council will consider the Parish Place Plan at the next meeting which may require updating particularly as the Council had received a Neighbourhood Fund Payment of £7,773.19 which has to be spent on local infrastructure within the next five years.

Planning Application 23/01368/FULL – Use of approved holiday let as permanent residential dwelling - The Old Bull Pen Ashford Farm - The Parish Council would require further information in relation to this application. There is no supporting evidence such as a Design and Access Statement. If the request is for Marketable Housing as it is within the Countryside to meet current policy, it would need to be for an Affordable Housing application. Suggest further information is supplied.

The Chair will look at the bridge along Salmore Lane and if required place an appropriate warning notice while the matter is reported to Shropshire Council to investigate.
