Dear Grahame, Gordon and Tony

Following the discussions last week at the Parish Council meeting and Gordon's suggestion to look at the ecological report on the development I have found and reviewed the attached Ecological Appraisal which was submitted as part of the planning permission. I also attach an excerpt from it (one page word document) which covers bats and lighting. The yellow highlights in the word document are mine, the most important of which (in my view) is the following statement: "• Any external security lighting should be set on motion-sensors and short (1min) timers. "As none of the Church Lane residents who have expressed unhappiness about the current external lighting on the house nearest the church car park want to upset the new residents there by raising the issue with them directly, we would prefer it if the Parish Council could take up the matter with Chris Moss and Jacob Goodenough (who attended the meeting last week) as representatives of the developer and new residents. Would this be possible please?
