20.54 Welcome by the Chair

Chairman Christine Jones welcomed everyone to the meeting.

20.55 Apologies for absence and reasons:

20.56 Declarations of Interest: a) Pecuniary b) Personal

There were none at this time

20.57 Public Session:

There were no members of the public presence and no questions filed in advance of the meeting

Cllr Chris Wilson joined the meeting

20.58 Minutes:

The list of Committee Representatives in the draft minutes required amendment to include Cllr Hugh Kirton on the Village Hall Trust, Cllr Don Hickman on the Nature Reserve Management Committee, and Cllrs David Beechey and Robert Parry on the Relief in Need.

With these amendments, it was proposed, seconded, and **resolved** to accept the minutes of the Council meeting held on Tuesday 15th September 2020 as a true record

20.59 Matters Arising

- **a) Memorial Bench** there has been no update on this project, the Parish Clerk said she would chase this up
- b) Highways there has been no updates on the proposals regarding Rectory Road and Long Lane. Cllr Ed Bird agreed to make enquiries about it. The Parish Clerk said she would send him correspondence received to date
- c) Casual Vacancy Cllr Chris Wilson advised the Council that he had passed on the email sent by the Parish Clerk advertising the Council Vacancy to RAF Cosford personnel.
- d) Contribution towards services— Cllr David Dale reported to Councillors about the request from Albrighton Parish Council to contribute towards the Albrighton Flyer, Albrighton Library and the village planters. He said that he had looked at the numbers in the invoices and in his opinion there were some inconsistencies in the figures. As regards the charges, he expressed the view that there should be absolute transparency and this should be supported with paper documentation. The services were not an issue as they are valued by parishioners in both parishes. He suggested a meeting with Albrighton Parish Council so the numbers could be properly understood, there must be transparency or we shouldn't pay it. It needs to be a two-way process, and a proper dialogue on shared issues.

Cllr Christine Jones, Chairman, said that there had not been a meeting between the Chairs since lockdown, this is communication but no meetings have been requested between either side.

It was proposed, seconded, and **agreed**, that a meeting should take place between the Chairmen and Vice-Chairmen to clarify the issue.

e) Benches repair – Cllr Robert Parry updated the Parish Council on the condition of two benches. The Mick Owen memorial bench needs repositioning. Both benches need serious repair or replacement. Cllr Parry estimated that replacements with basework would cost around £1500. He estimated that he could repair the benches for £400; it eight and possibly nine pieces of oak and would include groundwork costing about £250.

It was proposed, seconded and **resolved**, that a £500 be set-aside for the project and that Cllr Robert Parry source, repair and provide a pro-forma invoice to complete the work.

- c) Appointment of Internal Auditor it was proposed, seconded, and resolved to appoint John Henry of JDH Business Services was appointed as Internal Auditor for the financial year 2020-21

20.62 Correspondence: For Action

- a) Shropshire Council Maintenance a request was considered from Edward Andrews of Shropshire Council for consideration of a contribution from the Parish Council towards the cost of maintenance of the Nature Reserve this year. It was agreed that a breakdown of costs should be requested before giving the matter full consideration.
- b) Flagpole a request has been made to contribute towards the cost of a flagpole to be placed outside the Red House. The Parish Council voted against involvement in the project in February but had been asked to reconsider by Albrighton Parish Council. The project has not been as expensive as was predicted and the contribution of £91.77 was requested. There was no proposal in favour of supporting the flagpole so the decision of February stands.
- c) London Hearts Charity the Operations Manager of London Hearts (Charity Number 1180901) has contacted the Parish Council with an offer on heavily discounted special packages as part of a programme to get more defibrillators installed across the country. This was noted for future reference.
