Minutes of the Parish Council Meeting held in Eastling Village Hall on 15 July 2025

Present: Cllr Julia Bailey (Chairman), Cllr Annie Adams, Cllr Caroline Gilbert, Cllr Barrie Neaves and Cllr John Payne; and Mrs Wendy Licence (Clerk).

Cllr Bailey welcomed everyone to the meeting

## 1. Apologies

All Members were present.

Apologies had been received from County Councillor Rich Lehman.

#### 2. Declarations of interest

Cllr Adams declared a significant interest in item 8iii as a Trustee of the Village Hall which stands to benefit from the request.

# 3. Minutes of the Annual Parish Council Meeting Held on 13 May 2025

It was **AGREED UNANIMOUSLY** to accept the minutes of the Annual Parish Council Meeting held on 13 May 2025 as a true record. The minutes were duly signed by Cllr Bailey.

### 6. Chairman's Report

Cllr Bailey said there have been problems in the village regarding electricity outages.

Cllr Neaves said the issue seems to be weather related.

ACTION: Clerk to report to UKPN

Cllr Neaves reported that he had attended a meeting about Local Government Reorganisation. It is expected that Council Tax will increase for swale residents as surrounding areas have higher Council Tax. The reorganisation will cost £17,000,000 and will be shared amongst the community. Government guidance is that each unitary should serve 500,000 people; Kent has a population of 1,600,000, expected to go up to 1,800,000, and guidance is being sought if three or four unitary authorities will be created. There will be two tiers of local Government, Unitary Authorities and Town and Parish Councils. They are trying to match the Unitary Authorities in with the health districts. The report goes to Government in November; they may possibly be a consultation with the parishes beforehand. There is no proposal for a public consultation.

Cllr Bailey thanked Cllr Neaves for attending the meeting.

6.50pm Cllr Payne arrived at the meeting

Cllr Bailey reported that Mr Ben Binder, Farm Manager at the Belmont Estate for twenty-five years is moving to another farm management post. The parish Council is extremely grateful for his help with the maintenance of the hedgerows in the village.

#### 8. Finance

#### i. Finance Report

Cllr Payne informed Members that there is £14,255 in the bank; the Council has received £187.50 VAT repayment. There has been another request for support from Swale Pride, the Council agreed not to contribute as the request did not meet the Council's criteria for making grants.

#### ii. To consider invoices and cheques raised

It was **AGREED UNANIMOUSLY** to pay Mr L Robbins £105 for the internal audit.

#### iii. To consider request for a donation towards Foodbank Hub at Eastling Village Hall

Councillors considered the request. There was no budget regarding costings and there was no proof of need. It was noted that this was for a four-month trial period. It was **AGREED UNANIMOUSLY** to make a grant of £200 and to request to see costings for the project and also number of residents using the hub before agreeing further support.

Councillors considered the report and the auditor's comment about public rights but noted that as the auditor did not complete the audit before the May meeting, the Council was unable to approve the Annual Return until the July meeting. The auditor would be requested to carry out the audit earlier to ensure the deadline is met.
