> Thank you for your e-mail, which is in fact a request under the Freedom of Information Act. I have had an on-going similar request which I have just been able to meet, as I have been awaiting the receipt of documents from our Solicitor. So I don't have to take the required 20 days under the FOI Act.

> There are three documents which may be of interest to you which will cost in total £1.60, there are 8 A3 copies at 20p each. However, I will repeat what I have said to another resident in this regard, which is that I will need to take

legal opinion on whether there are further documents that have superseded the three documents that I can release to you. For an example when Days Field was declared surplus to requirements in 2005, the Town Council had to obtain a Section 8 permission to dispose of the land from the then Secretary of State Hazel Blairs. This was granted, releasing the council from the allotment requirement, the beneficiaries of any sale will be the inhabitants of the Town, of which the Town Council are their elected representatives.

> I will therefore offer to meet with you, should you wish to discuss the matter in greater detail and to better understand the reasoning for the request. If that is of interest to you, please let me have some dates and times when you may be available and hopefully we can find a mutually agreeable time to meet.
